- 1.) Diminish Certificate 22869 (junior priority) to a supplemental water right and then include both certificates in transfer (75333 as primary & 22869 as supplemental). OFF lands for both of these certificates should be transferred together to avoid enlargement/expansion of the water rights. All supplemental water rights for same lands should be included in this transfer as well.
- 2.) Cancel or move/transfer primary water right present (75333) for "ON" lands to avoid layering two primary water rights for the same lands.

A Headgate should be required prior to diverting water.

b. The water user shall maintain the meters or measuring devices in good working order.

c. The water user shall allow the Watermaster access to the meters or measuring devices; provided however, where the meters or measuring devices are located within a private structure, the Watermaster shall request access upon reasonable notice.

The water user shall maintain such devices in good working order. A written waiver may be obtained, if in the judgment of the Director, the installation of weirs or other suitable measuring devices, or the adjustable outlet valve, will provide no public benefit.
