- 1.) Certificate 75333: All "FROM" lands are currently layered with another primary water right (Certificate 75337). Un-layering of two primary water rights for the same lands will result in enlargement/expansion of the water rights. Alternatives: Diminish primary water right with junior priority date to supplemental, transfer primary and all supplemental water rights for same lands together.
- 2.) Certificate 75350: "FROM" lands in Section 22 are currently layered with a primary permit (G-2042). Un-layering of two primary water rights for the same lands will result in enlargement/expansion of the water rights. Alternatives: Diminish primary permit to supplemental (permit amendment) and then transfer primary and all supplemental water rights for same lands together.
- 3.) <u>Certificate 75350</u>: Supplemental "FROM" acres on table 2 are not mapped and do not exist on certificate. <u>Alternatives</u>: These acres are not subject to transfer.
- 4.) Certificate 75350: Section 22 (NE, NE & SE, NE) there is a supplemental water right existing for the same "FROM" lands (Certificate 75337). This transfer is proposing to transfer this supplemental water right to different "TO" lands than the primary.

 Alternatives: Transfer primary and supplemental water rights for same lands together to same "TO" lands.
- 5.) <u>Certificate 75350</u>: Measuring distances on Table 1 for POD #10 (Malheur Reservoir) are not described correctly and do not match Certificate. <u>Alternatives</u>: Amend Table 1 in transfer application to correctly reflect measuring distances listed on certificate.
- 6.) <u>Certificate 75332</u>: It is proposed in this transfer application to change POD (from Low Line Ditch to Pole Creek Reservoir). This would change the source that is currently authorized under this certificate and could potentially **injure** existing water users that rely on Pole Creek Reservoir as their source. <u>Alternatives</u>: Source of water under a water right is not subject to transfer.
- 7.) Certificate 75332: All "FROM" lands are currently layered with another primary permit (G-17367). Un-layering of two primary water rights for the same lands will result in enlargement/expansion of the water rights. There are also supplemental water rights for the same lands that are not included in this transfer. Alternatives: Diminish primary permit to supplemental (permit amendment) and then transfer primary and all supplemental water rights for same lands together.
