Temporary Drought Transfer Review Criteria

- Water has been used within the last five years according to the terms and conditions of the right. There is no evidence available that would demonstrate that the right is subject to forfeiture under ORS 540.610.

I have completed my review of drought temporary transfer T-13765. I found only 1 discrepancy, which will need a revision. Table 2 "FROM" lands identifies 11.8 acres in NE NE, Lot 1, Section 23, T305, R4W, WM. However, Certificate 37198 only authorizes 11.6 acres. Based on this information, the total amount to be transferred would be 19.8 acres, not 20.0, as the table and map indicates. You will need to revise Table 2 and the map, and resubmit, so that I may continue process T-13765. Once complete, you may just email to me.
