- On September 27, 2021, OCHOCO Irrigation District (OID) filed a district transfer application to permanently change the place of use under Certificates 82246 and 82247. The Department assigned the application number T-13838.
- Notice of the District Permanent Transfer Application was published on October 12, 2021, pursuant to ORS 540.580 and OAR 690-385-4400. No comments were filed in response to the notice.
- January 3, 2022, OID submitted maps with minor corrections, and on January 4, 2022, OID submitted corrected place of use tables.
- The U.S. Bureau of Reclamation was notified of the transfer application on October 12, 2021; no comments were received within 90 days of the notification.
- On February 1, 2017, OID modified the application to include supplemental water right certificates, and on February 16, 2017, OID submitted superseding correcting maps.

This final order in a contested case and is subject to judicial review by the Court of Appeals under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482(1). Pursuant to ORS 536.075(2) and OAR 137-003-0675, you may petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

Within 20 days after this final order is issued (i.e., mailing date), the district or any protestant may file with the commission exceptions to the final order. The commission shall issue an order granting or denying the exceptions within 30 days after receiving the exceptions. ORS 540.580(10).

- 6. Water right Certificates 82246 and 82247 are modified. After satisfactory proof of completion has been determined by the Department, superseding water right certificates will be issued when the Department determines it is necessary for record keeping.


