FINAL ORDER APPROVING A DISTRICT TEMPORARY TRANSFER

#### Authority

Oregon Revised Statute (ORS) 540.570 establishes the process in which a district may submit a request to temporarily transfer a water right within district boundaries. Oregon Administrative Rule (OAR) Chapter 690, Division 385 implements the statutes and provides the Department's procedures and criteria for evaluating district transfer applications.

#### **Findings of Fact**

- On April 18, 2022, Columbia Improvement District (CID) filed a district transfer application to temporarily change the places of use within the boundaries of the irrigation district under Certificates 94871, 94873, and 94874. The Department assigned the application number T-13977.
- Notice of the application for transfer was published on April 26, 2022, pursuant to ORS 540.570 and OAR 690-385-3400.
- 3. The portion of the first right to be transferred is as follows:

- The district temporary transfer application satisfies the criteria of ORS 540.570 and OAR 690-385-3000, contains the information required under OAR 690-385-3200, and includes a map meeting the requirements of OAR 690-385-3300.
- 10. Water has been used within the last five years according to the terms and conditions of the rights. There is no evidence available that would demonstrate that the rights are subject to forfeiture under ORS 540.610.
- 11. The water rights are subject to transfer as defined in OAR 690-385-0100(17).

- Diversion structures, district canals, pumps, pump stations, ditches, pipeline, and sprinkler systems sufficient to use the full amount of water allowed under the existing rights are present.
- 13. Certificates 49726, 49727, 55316, and 55317 are appurtenant to some of the lands upon which the proposed places of use under Certificates 94871, 94873, and 94874, as described in Findings of Fact 4, 6, and 8, above, are to be used under Temporary Transfer T-13977. Certificates 49726, 49727, 55316, and 55317 are all for use of groundwater, and are each a deficient rate right as described in OAR 690-300-0010 (11). Certificates 94871, 94873, and 94874, also deficient rate rights, may therefore, for the duration of this temporary Transfer T-13977, be layered with these primary groundwater rights.
- 14. The watermaster review dated May 23, 2022, indicates the proposed changes in place of use, as conditioned, will not result in enlargement of the rights as defined in OAR 690-385-0100(6) nor result in injury to other water rights as defined in OAR 690-385-0100(4).
- 15. All other applicable requirements for district temporary water right transfers are met.

#### Conclusions of Law

- The proposed change in place of use, as conditioned, will not result in enlargement of the rights as defined in OAR 690-385-0100(6).
- The proposed change in place of use, as conditioned will not result in injury to other water rights as defined in OAR 690-385-0100(4).
- The temporary change in place of use proposed in Temporary Transfer Application T-13977, as conditioned above, is consistent with the requirements of ORS 540.570 and OAR 690-385-3500.

#### Now, therefore, it is ORDERED:

- The temporary changes in place of use proposed in Transfer Application T-13977, as conditioned, are approved.
- The former places of use shall not be irrigated as part of these water rights during the 2022 irrigation season.
- 3. The use shall revert to the authorized place of use after the 2022 irrigation season.
- 4. Any application for permanent transfer of Certificates 94871, 94873, and 94874 shall be subject to a full and complete review to determine consistency with the requirements of OAR Chapter 690, Divisions 380 or 385. Approval of this temporary transfer does not establish a precedent for approval of a subsequent application filed for a permanent transfer.

- The time during which water is used under this approved temporary transfer does not apply toward a finding of forfeiture of Certificates 94871, 94873, and 94874, under ORS 540.610.
- Use of water on lands from which the right is transferred and in the new temporary location during the same irrigation season or calendar year is prohibited and may subject the district and the landowner to civil penalties.
- The water user shall maintain and operate the existing measurement devices and shall make such improvements as may be required by the Department.
- The use of water under this temporary transfer may be conditioned or revoked at any time to the extent necessary to avoid injury if the Department finds the transfer causes injury to any existing water right.
- The use of water at the temporary place of use authorized by this transfer shall be in accordance with the terms and conditions of Certificates 94871, 94873, and 94874.
- 10. Water use measurement conditions:
  - a. Before water use may begin under this order, the water user shall install a totalizing flow meter, or, with prior approval of the Director, another suitable measuring device, at each point of diversion.
  - b. The water user shall maintain the meters or measuring devices in good working order.
  - c. The water user shall allow the Watermaster access to the meters or measuring devices; provided however, where the meters or measuring devices are located within a private structure, the Watermaster shall request access upon reasonable notice.
- The use of the remaining water rights described by Certificates 94871, 94873, and 94874 not involved in this transfer shall continue to be in accordance with the terms and conditions of Certificates 94871, 94873, and 94874.
