#### Authority

Oregon Revised Statute (ORS) 537.705 and 540.505 to 540.580 establish the process in which a water right holder may submit a request to temporarily transfer the place of use and, if necessary to convey the water to the temporary place of use, the point of appropriation authorized under an existing water right. Oregon Administrative Rule (OAR) Chapter 690, Division 380 implements the statutes and provides the Department's procedures and criteria for evaluating transfer applications.

#### **Findings of Fact**

- On June 9, 2022, ST HILAIRE BROTHERS HERMISTON FARM, LLC filed an application to temporarily change the place of use under Certificate 80295 for a period of 5 years. The Department assigned the application number T-14028.
- Notice of the application for transfer was published on June 24, 2022, pursuant to OAR 690-380-4000.
- 3. The portion of the right to be transferred is as follows:

Certificate:	80295 in the name of MERLE GEHRKE (perfected under Permit G-7929)
Use:	IRRIGATION of 408.8 ACRES
Priority Date:	FEBRUARY 15, 1978
Rate:	5.11 CUBIC FEET PER SECOND (CFS)

This is a final order in other than a contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.484(2). Pursuant to ORS 536.075 and OAR 137-004-0080, you may petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

#### Limit/Duty: The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year FOUR WELLS, in the STAGE GULCH BASIN

4. Transfer Application T-14028 proposes to change the place of use of the right to:

#### Temporary Transfer Review Criteria

- 5. Water has been sed within the last five years according to the terms and conditions of the right. There is no information in the record that would demonstrate that the right is subject to forfeiture under ORS 540.610.
- Water use Permit S-55183 is appurtenant to some of the land to which Temporary Transfer T-14028 is proposed to be used. The primary irrigation use under water use Permit S-55183 shall remain unexercised during the term of this temporary transfer.
- 7. A pump, pipeline, and sprinkler system sufficient to use the full amount of water allowed under the existing right are present.
- The proposed change would prevent the lands from which the water right is removed during the period of the temporary transfer from receiving water under the transferred right, as required by ORS 540.523(7).
- 9. The proposed change would not result in injury to other water rights. This finding is made through an abbreviated review recognizing that the transfer may be revoked under ORS 540.523(5) if the Department later finds that the transfer is causing injury to any existing water right.

#### Conclusions of Law

The temporary change in place of use proposed in Temporary Transfer Application T-14028 is consistent with the requirements of ORS 540.523 and OAR 690-380-8000.

#### Now, therefore, it is ORDERED:

 The temporary change in place of use proposed in Temporary Transfer Application T-14028 is approved.

- 2. The former place of use shall not be irrigated as part of this water right during the 2023, 2024, 2025, 2026 and 2027 irrigation seasons.
- 3. The use shall revert to the authorized place of use at the end of the 2027 irrigation season.
- 4. The approval of this temporary transfer may be revoked or modified if the Department finds the change causes injury to any existing water right.
- A subsequent application for permanent transfer of Certificate 80295 shall be subject to a full and complete review to determine consistency with the requirements of OAR Chapter 690, Division 380. Approval of this temporary transfer does not establish a precedent for approval of a subsequent application filed for a permanent transfer.
- 6. Water use measurement conditions:
  - a. Before water use may begin under this order, the water user shall install a totalizing flow meter, or, with prior approval of the Director, another suitable measuring device, at each point of appropriation.
  - b. The water user shall maintain the meters or measuring devices in good working order.
  - c. The water user shall allow the Watermaster access to the meters or measuring devices; provided however, where the meters or measuring devices are located within a private structure, the Watermaster shall request access upon reasonable notice.
- 7. The use of water at the temporary place of use authorized by this transfer shall be in accordance with the terms and conditions of Certificate 80295.
- 8. The time during which water is used under this approved temporary transfer does not apply toward a finding of forfeiture under ORS 540.610.

9. The use of the remaining water right described by Certificate 80295 shall continue to be in accordance with the terms and conditions of Certificate 80295.

By copy of this letter, we are asking the Watermaster for a report regarding the potential for injury to existing water rights which may be caused by the requested change.

Except as provided under ORS 540.510(3) for municipalities, you may not **temporarily** use water at the new place of use or from the new point of diversion/appropriation until a final order approving the temporary transfer application has been issued by the Department. Additionally, pursuant to OAR 690-380-8010, the lands <u>from</u> which an irrigation water right is to be temporarily transferred and the land <u>to</u> which the right is to be temporarily transferred may not both receive water during the same season. If the temporary transfer is approved during an irrigation season and water has already been used at the currently authorized location during that season, then the temporary transfer will not take effect until the following season.

If the land is sold before the temporary transfer is approved, the buyer's consent to the temporary transfer will be required unless a recorded deed or other legal document clearly established that the water right was not conveyed in the sale.



There are four wells on the property. Well #1 (UMAT 3007) is 600 feet deep, Well #2 (UMAT 3004) is 600 feet deep, Well #4 (UMAT 3000) is 665 feet deep, and Well #4 (UMAT 2999) is 950 feet deep. Wells #1, #2, and #3 all have 16 inch casings while Well #4 has an 18" casing. There are 500 hp turbine pumps in each well. Well #2 has a 50 hp centrifugal booster pump and Well #3 has two 60 hp centrifugal booster pumps. The system has a looping network of mainlines that connect the four wells. This network is also connected to a regulating reservoir that maintains a constant head throughout the system. Twenty-seven center pivots are supplied off the mainline loop through laterals. In addition to the center pivots, areas can be irrigated using wheellines and/or handlines from risers located along sections of mainline. The head maintained by the regulating reservoir is adequate to operate all but three of the center pivots which each has its own small booster pump. All the pipelines are buried; many of the mainline sections are steel while most of the laterals are PVC. Pipe sizes of the various sections vary depending on the required capacity through that section; sizes range from 20 inch steel down to 6 inch PVC. There is a flow meter at each of the four wells. These meters are read weekly and monthly totals are reported annually.

## PARTIES

THIS FARM GROUND AND IRRIGATION SYSTEMS LEASE is entered into between ST. HILAIRE BROTHERS HERMISTON FARM, LLC, an Oregon limited liability company ("LANDLORD"), and JSH FARMS, INC., a Washington Corporation authorized to do business in Oregon ("TENANT"), on the date LANDLORD and TENANT have both signed this agreement. LANDLORD and TENANT are referred to in this lease together as the "parties".

## Π

### AGREEMENTS

IN CONSIDERATION of the mutual promises, performances and covenants of the parties contained in this agreement, TENANT leases from LANDLORD, and LANDLORD leases to TENANT, the below described "premises" on the following terms and conditions.

#### 1. PREMISES LEASED.

The "premises" leased consist of that real property known as the Piercy Farm and all of its irrigation equipment and water rights.

#### 2. TERM.

This is a five (5) crop year lease, and the term of this lease shall begin on November 1, 2014, and shall end and terminate as to each circle leased when TENANT has harvested all of its crops from that circle in 2019, or on October 31, 2019, whichever date is earlier. If TENANT stays on the farm after the expiration of the term, this lease shall continue on a year-to-year basis on the same terms.

#### 3. RENT.

a. As rent for each crop year, \$650 an acre rent shall be paid for each acre farmed which can receive 3 acre feet of water in that crop year as allocated by the Oregon Department of Water Resources. The rent shall be paid 50% on March 1 of each year and 50% on October 1 of each year. TENANT may pay off the rent in advance at any time—even in year before the crop year.

 All rent payments shall be made to LANDLORD at LANDLORD's notice address in this lease.

### 4. ELECTRICITY POWER AND DEMAND CHARGES.

- a. TENANT shall pay all electricity charges and electricity demand charges necessary to operate the irrigation systems for each crop year when those charges are due.

#### 5. TAXES.

- a. <u>Insurance.</u> TENANT shall carry public liability and personal injury insurance with limits of not less than \$1,000,000 combined single limit, insuring against claims made arising out of TENANT's farming activities on the premises. Proof of said insurance shall be provided to LANDLORD within fifteen days of request and within fifteen days of the date both parties have signed this agreement. Said insurance shall name LANDLORD as an additional insured.
- b. <u>Indemnification</u>.
