DETERMINATION OF SATISFACTORY
PROOF OF COMPLETION FOR A
PERMANENT DISTRICT TRANSFER
AND LOSS OF RIGHT

Authority

Oregon Administrative Rule (OAR) 690-385-7400 describes the documentation the district must file with the Department in order to provide proof of use.

OAR 690-385-7600 provides in pertinent part that satisfactory proof shall be (a) a determination by the Department that application of water to beneficial use under the terms of the transfer final order was completed to the extent authorized, or (b) a determination by the Department that the application of water to a beneficial use under the terms of the transfer final order was completed to an extent less than authorized.

Oregon Revised Statute (ORS) 540.530(2)(a) and OAR 690-385-7600 authorize the Department to issue or modify a certificate of water right upon satisfactory proof of completion of the change or changes authorized by a final order approving a permanent district transfer.

Applicant

OWYHEE IRRIGATION DISTRICT 422 THUNDEREGG BLVD NYSSA, OR 97913

Findings of Fact

- On March 1, 2023, the Department signed a final order, which was mailed on March 2, 2023, and recorded in Special Order Volume 127, Pages 867-872, approving Transfer Application T-14123 involving Certificate 75691. The final order established October 1, 2024, as the date for completion of the authorized changes in place of use.
- On September 30, 2024, the Department received a Claim of Beneficial Use (CBU) and associated maps from the applicant for Transfer Application T-14123 satisfying the requirements for providing proof of use under OAR 690-385-7400.

NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is a final order in other than contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.484(2). Pursuant to ORS 536.075 and OAR 137-004-0080 you may either petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

- 3. On January 8, 2025, the Department received a set of replacement maps to correct a printing error, and revised site reports from the applicant for Transfer Application T-14123.
- 4. The Department reviewed the CBU and maps submitted by the applicant for Transfer Application T- 14123.
- 5. The CBU did not contain a map of the point of diversion from the source. However, since the transfer involved the transfer of places of use only within an irrigation district and did not involve a change in the point of diversion, the existing maps on file with the Department are sufficient to identify the point of diversion from the source.
- 6. The proposed place of use for Certificate 75691 as approved the final order for Transfer Application T-14123, and as recorded in Special Order Volume 127, Pages 867-872, is shown in Table 1, below:

7. Based on the review of evidence submitted by the applicant, the Department finds the application of water to a beneficial use under the terms of the transfer final order for T- 14123 was completed to an extent authorized in the transfer. The Department finds that beneficial use was made to the extent shown in Table 1, above.

Conclusions of Law

- 1. The Applicant has submitted proof of use pursuant to OAR 690-385-7400.
- 2. Application of water to a beneficial use under the terms of the transfer final order has been made to the extent shown in Table 1, above.
- The applicant has demonstrated proof of completion under T-14123 to the satisfaction of the Department.
- The Department is authorized to issue or modify certificates of water rights involved in transfer T-14123 consistent with this determination of satisfactory proof of completion.

Now, therefore, it is ORDERED:

 Water right Certificate is modified as shown in Table 1, above. The Department will issue a superseding certificate describing this right when it determines it is necessary for record keeping.



Oregon Revised Statutes (ORS) 540.570 to 540.580 establish the process in which a district may submit a request to transfer a water right within district boundaries. Oregon Administrative Rule (OAR) Chapter 690, Division 385 implements the statutes and provides the Department's procedures and criteria for evaluating district transfer applications.

Applicant

OWYHEE IRRIGATION DISTRICT 422 THUNDEREGG BLVD NYSSA, OR 97913

Findings of Fact

- On November 21, 2022, Owyhee Irrigation District (OID) filed a completed district transfer application to permanently change the place of use under Certificate 75691 and Permit G-17562. The Department assigned the application number T-14123.
- In addition, OID requested the cancellation of a portion of Certificate 75708 for supplemental irrigation which is layered with primary irrigation on certain authorized places of use subject to this transfer.
- On July 2, 2020, Permit G-17562 was assigned from Vaugh Schulthies, Barbara Schulthies, and Mountain Valley Enterprises, Inc. to SBWC, LLC and NORTHWEST FARM CREDIT SERVICES, FLCA.
- Notice of the District Permanent Transfer Application was published on November 29, 2022, pursuant to ORS 540.580 and OAR 690-385-4400. No comments were filed in response to the notice.

This final order in a contested case and is subject to judicial review by the Court of Appeals under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482(1). Pursuant to ORS 536.075(2) and OAR 137-003-0675, you may petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

Within 20 days after this final order is issued (i.e., mailing date), the district or any protestant may file with the commission exceptions to the final order. The commission shall issue an order granting or denying the exceptions within 30 days after receiving the exceptions. ORS 540.580(10).

- The U.S. Bureau of Reclamation was notified of the transfer application on December 8, 2022; no comments were received within 90 days of the notification.
- 6. On December 16 & 19, 2022, and February 9, 2023, OID submitted corrections and amendments to the application place of use tables and maps.
- 7. The portion of the right to be transferred is as follows:

Certificate: 75691 in the name of the UNITED STATES OF AMERICA; BUREAU OF RECLAMATION (perfected under Permit S-8171)

Use: IRRIGATION of 12.54 acres

Priority Date: FEBRUARY 15, 1916, for stored water and AUGUST 19, 1924, for direct flow

16. The portion of the water right as evidenced by Water Right Certificate 75708 which has been abandoned is for supplemental irrigation on certain lands described in Finding of Fact #7. Partial Diminution of Permit G-17562

Conclusions of Law

The proposed changes in place of use as proposed in Transfer Application T-14123 comply with and satisfy the requirements of ORS 540.580 and OAR 690-385-4500, and the requested portion of Certificate 75708 should be diminished from primary irrigation to supplemental irrigation.

Now, therefore, it is ORDERED:

- The proposed change in place of use to the water right evidenced by Certificate 75691 is approved.
- The portion of Certificate 75708 appurtenant to the land described in Finding of Fact #17 is cancelled.
- Certificate 75708 in the name of Owyhee Irrigation District is modified to reflect the
 cancellation of 1.0 acres, as described in Findings of Fact #17 and 18. A superseding water
 right certificate will be issued when the Department determines it is necessary for record

- 4. - Water right Certificate 75691 is modified. After satisfactory proof of completion has been determined by the Department, a superseding water right certificate will be issued when the Department determines it is necessary for record keeping.

Static Water Level Conditions

The Department requires the water user to obtain, from a qualified individual (see below), and report annual static water levels for each well on the permit. The static water level shall be measured in the month of March. Reports shall be submitted to the Department within 30 days of measurement.

The permittee shall report an initial March static water-level measurement once well construction is complete and annual measurements thereafter. Annual measurements are required whether or not the well is used. The first annual measurement will establish a reference level against which future measurements will be compared. However, the Director may establish the reference level based on an analysis of other waterlevel data. The Director may require the user to obtain and report additional water levels each year if more data are needed to evaluate the aquifer system.

All measurements shall be made by a certified water rights examiner, registered professional geologist, registered professional engineer, licensed well constructor or pump installer licensed by the Construction Contractors Board. Measurements shall be submitted on forms provided by, or specified by, the Department. Measurements shall be made with equipment that is accurate to at least the standards specified in OAR 690-217-0045. The Department requires the individual performing the measurement to:

- Associate each measurement with an owner's well name or number and a Department well log ID; and
- Report water levels to at least the nearest tenth of a foot as depth-to-water below ground surface; and
- Specify the method of measurement; and

D. Certify the accuracy of all measurements and calculations reported to the Department.

The Department may require the discontinuance of groundwater use, or reduce the rate or volume of withdrawal, from the well(s) if any of the following events occur:

- A. Annual water-level measurements reveal an average water-level decline of two or more feet per year for three consecutive years; or
- B. Annual water-level measurements reveal a water-level decline of six or more feet in fewer than five consecutive years; or
- C. Annual water-level measurements reveal a water-level decline of 10 or more feet; or
- D. Hydraulic interference leads to a decline of 10 or more feet in any neighboring well with senior priority.

The period of restricted use shall continue until the water level rises above the decline level which triggered the action or the Department determines, based on the permittee's and/or the Department's data and analysis, that no action is necessary because the aquifer in question can sustain the observed declines without adversely impacting the resource or causing substantial interference with senior water rights. The water user shall not allow excessive decline, as defined in Commission rules, to occur within the aquifer as a result of use under this permit. If more than one well is involved, the water user may submit an alternative measurement and reporting plan for review and approval by the Department.

Dedicated Measuring Tube: Wells with pumps shall be equipped with a minimum 3/4-inch diameter, unobstructed, dedicated measuring tube pursuant to figure 200-5 in OAR 690-200. If a pump has been installed prior to the issuance of this permit, and if static water levels and pumping levels can be measured using an electrical tape, then the installation of the measuring tube can be delayed until such time that water levels cannot be measured or the pump is repaired or replaced.

Prior to using water from any well listed on this permit, the permittee shall ensure that the well has been assigned an OWRD Well Identification Number (Well ID tag), which shall be permanently attached to the well. The Well ID shall be used as a reference in any correspondence regarding the well, including any reports of water use, water level, or pump test data.

STANDARD CONDITIONS

Failure to comply with any of the provisions of this permit may result in action including, but not limited to, restrictions on the use, civil penalties, or cancellation of the permit.

If the number, location, source, or construction of any well deviates from that proposed in the permit application or required by permit conditions, this permit may be subject to cancellation, unless the Department authorizes the change in writing.

If substantial interference with surface water or a senior water right occurs due to withdrawal of water from any well listed on this permit, then use of water from the well(s) shall be discontinued or reduced and/or the schedule of withdrawal shall be regulated until or unless the Department approves or implements an alternative administrative action to mitigate the interference. The Department encourages junior and senior appropriators to jointly develop plans to mitigate interferences.

The well(s) shall be constructed and maintained in accordance with the General Standards for the Construction and Maintenance of Water Supply Wells in Oregon. The works shall be equipped with a usable access port adequate to determine water-level elevation in the well at all times.

If the riparian area is disturbed in the process of developing a point of appropriation, the permittee shall be responsible for restoration and enhancement of such riparian area in accordance with ODFW's Fish and Wildlife Habitat Mitigation Policy OAR 635-415. For purposes of mitigation, the ODFW Fish and Wildlife Habitat Mitigation Goals and Standards, OAR 635-415, shall be followed.

The use may be restricted if the quality of downstream waters decreases to the point that those waters no longer meet state or federal water quality standards due to reduced flows.

Where two or more water users agree among themselves as to the manner of rotation in the use of water and such agreement is placed in writing and filed by such water users with the watermaster, and such rotation system does not infringe upon such prior rights of any water user not a party to such rotation plan, the watermaster shall distribute the water according to such agreement.

Prior to receiving a certificate of water right, the permit holder shall submit to the Water Resources Department the results of a pump test meeting the Department's standards for each point of appropriation (well), unless an exemption has been obtained in writing under OAR 690-217. The Director may require water-level or pump-test data every ten years thereafter.

This permit is for the beneficial use of water without waste. The water user is advised that new regulations may require the use of best practical technologies or conservation practices to achieve this end.

By law, the land use associated with this water use must be in compliance with statewide land-use goals and any local acknowledged land-use plan.

Construction of the well shall be made within five years of the date of permit issuance. The deadline to begin construction may not be extended. This permit is subject to cancellation proceedings if the begin construction deadline is missed.


