Authority

Oregon Revised Statutes (ORS) 540.570 to 540.580 establish the process in which a district may submit a request to transfer a water right within district boundaries. Oregon Administrative Rule (OAR) Chapter 690, Division 385 implements the statutes and provides the Department's procedures and criteria for evaluating district transfer applications.

Findings of Fact

1. On May 5, 2023, Willow Creek District Improvement Company (WCDIC) filed a district transfer application to permanently change the place of use under Certificates 96666, 96673, 38861, 42435, and Permits S-54980 and S-55268. The Department assigned the application number T-14242.
2. Notice of the application for transfer was published on May 17, 2023, pursuant to ORS 540.580 and OAR 690-385-4400. No comments were filed in response to the notice.
3. The portion of the first right to be transferred is as follows:

Certificate: 96673 issued in the names of WILLOW CREEK DISTRICT IMPROVEMENT COMPANY and BRIAN THOMPSON (confirmed by decree of the Circuit Court of the State of Oregon for Morrow County)

This final order in a contested case and is subject to judicial review by the Court of Appeals under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482(1). Pursuant to ORS 536.075(2) and OAR 137-003-0675, you may petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

Within 20 days after this final order is issued (i.e., mailing date), the district or any protestant may file with the commission exceptions to the final order. The commission shall issue an order granting or denying the exceptions within 30 days after receiving the exceptions. ORS 540.580(10).

7. Certificate 96666 was issued to confirm an additional point of diversion as proposed in Transfer T-11699. Certificate 96666 superseded the entirety of Certificate 114. Certificate 114 was issued from a decree of the Circuit Court of the State of Oregon for Morrow County dated December 4, 1910, which confirmed a total of 44.26 acres in the Findings and Determination for Water Division No. 2, Gilliam, and Morrow Counties, dated April 13, 1910. The place of use listed in the decree, and Certificates 114 and 96666 each authorized a total of 44.26 acres at the same location as the 44.26 listed as the authorized place of use as shown in Finding of Fact # 6, above. Both Certificates 114 and 96666 contained the same scrivener's error, wherein 1891 was listed as the priority date for 25 acres, and 1905 was listed as the priority date for 23 acres, which exceeded the total authorized acreage by over

3 acres. In this transfer T-14242, the applicant requested to transfer the total 44.26 acres, and designated 25 acres having a priority date of 1891, and 19.26 acres having a priority date of 1905.

16. The Department finds that the district permanent transfer application was submitted according to ORS 540.580 and OAR 690-385-4000, contains the information required under OARs 690-385-4200 and OAR 690-385-2000, and includes maps meeting the requirements of OARs 690-385-4300 and 690-385-2200.
17. The Department finds that the proposed district permanent transfer meets all the criteria set forth in ORS 540.580 and OAR 690-385-4000.
18. The water right is subject to transfer as defined in OAR 690-385-0100(17).
19. The proposed change in places of use, as conditioned will not result in enlargement of the right as defined in OAR 690-385-0100(4).
20. The proposed change in place of use will not result in injury to other water rights as defined in OAR 690-385-0100(6).
21. Any other applicable requirements for district permanent water right transfers are met as required in OAR 690-385-4500.


Conclusion of Law

The proposed changes in place of use as proposed in Transfer Application T-14242 comply with and satisfy the requirements of ORS 540.580 and OAR 690-385-4500.

Now, therefore, it is ORDERED:

1. The proposed changes in place of use, as conditioned, to the water right evidenced by Certificates 96666, 96673, 38861, 42435, and Permits S-54980 and S-55268 are approved.
2. The places of use from which the water rights are transferred off by Transfer T-14242 shall no longer be irrigated; Certificates 96666, 96673, 38861, and 42435, are cancelled.
3. Permits S-54980 and S-55268 are modified as described in Findings of Facts #11 & 12 and 13 & 14.
4. Water Use Measurement Conditions:
 - a. Before water use may begin under this order, the water user shall install a totalizing flow meter, or, with prior approval of the Director, another suitable measuring device, at each point of diversion (new and existing).
 - b. The water user shall maintain the meters or measuring devices in good working order.
 - c. The water user shall allow the Watermaster access to the meters or measuring devices; provided however, where the meters or measuring devices are located within a private structure, the Watermaster shall request access upon reasonable notice.
5. Full beneficial use of the water shall be made, consistent with the terms of this order, on or before **October 1, 2025**. A Claim of Beneficial Use shall be submitted by WCDIC to the Department within one year after the deadline for completion of the changes and full beneficial use of the water.
6. After proof of completion, new certificates confirming the rights transferred from Certificates 96666, 96673, 38861, and 42435 will be issued. Any water right certificate issued to confirm changes to Certificates 96666 and 96673 under Transfer T-14242 are to remain in the name of the name of Willow Creek District Improvement Company.
