By Decree of the Circuit Court for Grant County, Oregon, entered November 16, 1956, In the Matter of the Determination of the Relative Rights to the Use of the Waters of John Day River and its Tributaries, a water right was established in the name of M. F. Duncan for the use of the waters of Rock Creek for the irrigation of 3.3 acres in SW% SE%, Section 11, and 7.2 acres in NW% NE%, Section 14, Township 1 North, Range 19 East, W.M., with a date of priority of 1903. The date set for hearing in said notice was not less than thirty days after the last publication of the notice.

Mr. Howard Daggett, Watermaster of District No. 4, has filed a report to the effect that the proposed change in place of use and point of diversion of water may be made without injury to existing rights.






