

ORDER APPROVING TRANSFER NO. 2590

On December 2, 1971, Lawrence R. Starr filed an application in the office of the State Engineer for the approval of a change in point of diversion of water from Mill Creek, pursuant to the provisions of ORS 540.510 to 540.530.

By Decree of the Circuit Court for Union County, Oregon, entered March 13, 1924, In the Matter of the Determination of the Relative Rights to the Use of the Waters of Grande Ronde River and its Tributaries, a water right was established in the name of E. C. Myers for the use of the waters of Mill Creek for the irrigation of 4.0 acres in the SW% SW%, Section 1, Township 1 South, Range 38 East, W.M., with a date of priority of 1872. This right is evidenced by certificate recorded at page 6480, Volume 6, State Record of Water Right Certificates. These lands are irrigated by means of the Rinehart Ditch from a point of diversion located 1150 feet north and 300 feet east from the SW corner of Section 1 being within the SW% SW% of Section 1, Township 1 South, Range 38 East, W.M.

The applicant herein, owner of the lands above described, proposes to irrigate these lands from points of diversion to be located N 44° 46' E 939.7 feet and N 53° 05' E 800.2 feet from the SW corner of Section 1 being within the SW% SW% of Section 1, Township 1 South, Range 38 East, W.M.

Notice by publication as provided by ORS 540.520 was not given in connection with this application for the reason said section provides notice is not required on an application for a change in

point of diversion of water of less than one-fourth mile where there are no intervening diversions.

Mr. Boyd Hadden, Watermaster of District No. 6, has filed a report to the effect that the proposed change in point of diversion of water may be made without injury to existing rights.

No objections having been filed and it appearing that the proposed change in point of diversion of water may be made without injury to existing rights, the application should be approved.

NOW, THEREFORE, it hereby is ORDERED that the change in point of diversion of water from Mill Creek, to-wit:

From a point located 1150 feet north and 300 feet east from the SW corner of Section 1 being within the SW% SW% of Section 1, Township 1 South, Range 38 East, W.M.

To a point to be located N 44° 46' E 939.7 feet from the SW corner of Section 1 being within the SW% SW% of Section 1, Township 1 South, Range 38 East, W.M.

To a point to be located N 53° 05' E 800.2 feet from the SW corner of Section 1 being within the SW% SW% of Section 1, Township 1 South, Range 38 East, W.M.

for the irrigation of 4.0 acres in the SWM SWM, Section 1, Township 1 South, Range 38 East, W.M., with a date of priority of 1872, is approved.

It is FURTHER ORDERED that the construction work shall be completed and the change in point of diversion of water made on or before October 1, 1972.

It is FURTHER ORDERED that the quantity of water diverted at the new point of diversion shall not exceed the quantity of water available at the old point of diversion and shall not exceed three acre feet per acre in any irrigation season, diverted at a rate of not to exceed one-fortieth of a cubic foot per second per acre.

It is FURTHER ORDERED that the following provisions shall

be effective when in the judgement of the watermaster it becomes necessary to install headgates and measuring devices.

That the diversion works shall include an in-line flow meter, a weir, or other suitable device for measuring the water to which the applicant is entitled.

That the type and plans of the measuring device be approved by the watermaster before the beginning of construction work and that the weir or measuring device be installed under the general supervision of said watermaster.

It is FURTHER ORDERED that certificate of water right heretofore issued to E. C. Myers and recorded at page 6480, Volume 6,

State Record of Water Right Certificates, is canceled and upon receipt of proof satisfactory to the State Engineer of completion of
the authorized change in point of diversion, a certificate of water
right shall be issued to Lawrence R. Starr confirming said change in
point of diversion.
