On March 29, 1972, Clive L. Mitchell filed an application in the office of the State Engineer for the approval of a change in point of diversion and place of use of water from an unnamed creek, pursuant to the provisions of ORS 540.510 to 540.530.

Certificate of water right issued to Clive L. Mitchell and Reba F. Mitchell and recorded at page 15388, Volume 13, State Record of Water Right Certificates, confirms a right to the use of not to exceed 0.01 cubic foot per second of waters of an unnamed creek for the purpose of domestic and fire protection in the NWA NWA, Section 14, Township 9 South, Range 2 East, W.M., with a date of priority of June 28, 1938. The point of diversion for these purposes is located 850 feet South and 1,000 feet East from the NW corner of Section 14, being within the NWA NWA of Section 14, Township 9 South, Range 2 East, W.M.

Mr. Gene McGinnis, Watermaster of District No. 2, has filed a report to the effect that the proposed change in place of use and point of diversion of water may be made without injury to existing rights.

No objections having been filed and it appearing that the proposed change in place of use and point of diversion may be made without injury to existing rights, the application should be approved.

NOW, THEREFORE, it hereby is ORDERED that the change in place of use of water is approved and the water right hereinbefore described as appurtenant to the NW% NW% of Section 14, Township 9 South, Range 2 East, W.M., with a date of priority of June 28, 1938, be severed therefrom and simultaneously and without loss of priority transferred to the SW% SW% of Section 11, Township 9 South, Range 2 East, W.M.
