## FINDINGS OF FACTS

- On February 28, 2005, the Department received an affidavit from Vandehay Farms, Inc., 21408 NW Pihl Road, Banks, Oregon, stating that they are the owner of lands and the water right appurtenant as evidenced by Certificate 49749, State Record of Water Right Certificates. The affidavit further states they have obtained a different source of water for primary irrigation of these lands and requests the water right be diminished from a right for primary irrigation to a right for supplemental irrigation of the lands.
- 2. The water right to be diminished is the right described by Certificate 49749, State Record of Water Right Certificates. The water right allows the use of not to exceed 0.375 cubic foot per second of water from West Fork Dairy Creek, tributary to Dairy Creek, for irrigation of 30.0 acres. The priority date is December 19, 1938. The point of diversion is located in NW<sup>1</sup>/4 SW<sup>1</sup>/4, as projected within John Lousignout DLC 52, Section 12, Township 1 North, Range 4 West, W. M.; 440 feet South and 450 feet East from the W<sup>1</sup>/4 Corner of Section 12.
- 3. The affidavit requests the following lands be diminished from primary irrigation to supplemental irrigation:

The quantity of water associate with the 27.9 acres equals 0.349 cubic foot per second.

# CONCLUSIONS OF LAW

The Director of the Water Resources Department concludes that the portion of the right evidenced by Water Right Certificate 49749 as described in *Findings of Fact #3* has been diminished from primary irrigation to supplemental irrigation

## ORDER

## IT IS HEREBY ORDERED:

- 1. Certificate 49749 is canceled.
- The water right for irrigation of 27.9 acres as described by Certificate 49749 is diminished from a right for primary irrigation to a right for supplemental irrigation. The Department shall issue Certificate 81271, a new and superseding certificate, to confirm the diminution of the right

confirms the right to use the waters of WEST FORK DAIRY CR, a tributary of DAIRY CR, for IRRIGATION OF 2.1 ACRES AND SUPPLEMENTAL IRRIGATION OF 27.9 ACRES.

This right was perfected under Permit S-13388. The date of priority is DECEMBER 19, 1938. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.375 CUBIC FOOT PER SECOND (CFS), BEING 0.026 CFS FOR IRRIGATION AND 0.349 FOR SUPPLEMENTAL IRRIGATION, or its equivalent in case of rotation, measured at the point of diversion.

On March 5, 1974, A. C. Lyda filed an application in the office of the State Engineer for the approval of a change in place of use of water from West Fork Dairy Creek, pursuant to the provisions of ORS 540.510 to 540.530.

Certificate of water right issued to L. J. Heesacker and recorded at page 14207, Volume 12, State Record of Water Right Certificates, confirms a right to the use of not to exceed 1.55 cubic feet per second of water from West Fork Dairy Creek for the irrigation of 124.0 acres, with a date of priority of December 19, 1938. On March 27, 1973, an order was entered wherein the rights for the irrigation of 14.0 acres in NE<sup>1</sup>/<sub>2</sub> SE<sup>1</sup>/<sub>2</sub>, 4.0 acres in SE<sup>1</sup>/<sub>4</sub> SE<sup>1</sup>/<sub>4</sub>, Section 11, and 12.0 acres in NW<sup>1</sup>/<sub>2</sub> SW<sup>1</sup>/<sub>2</sub>, Section 12, Township 1 North, Range 4 West, W.M., became appurtenant to 2.0 acres in NE<sup>1</sup>/<sub>4</sub> NE<sup>1</sup>/<sub>4</sub>, 19.0 acres in SE<sup>1</sup>/<sub>4</sub> NE<sup>1</sup>/<sub>4</sub>, Section 11, and 9.0 acres in SW<sup>1</sup>/<sub>4</sub> NW<sup>1</sup>/<sub>4</sub>, Section 12, Township 1 North, Range 4 West, W.M. Satisfactory proof has been submitted to the State Engineer that water has been beneficially applied to these lands.

The applicant herein, owner of the land above described, proposes to transfer the water right therefrom, without loss of priority, to 14.0 acres in NE<sup>1</sup>/<sub>2</sub> SE<sup>1</sup>/<sub>4</sub>, 4.0 acres in SE<sup>1</sup>/<sub>2</sub> SE<sup>1</sup>/<sub>4</sub>, Section 11, and 12.0 acres in NW<sup>1</sup>/<sub>4</sub> SW<sup>1</sup>/<sub>4</sub>, Section 12, Township 1 North, Range 4 West, W.M.

Notice by publication as provided by ORS 540.520 was not given in connection with this application for the reason that said section provides notice is not required on an application for a change in place of use of water. Mr. Clayton Gardner, Watermaster of District No. 1, has filed a statement to the effect that the proposed change in place of use of water may be made without injury to existing rights.

No objections having been filed and it appearing that the proposed change in place of use may be made without injury to existing rights, the application should be approved.

NOW, THEREFORE, it hereby is ORDERED that the change in place of use of water is approved and the water right hereinbefore described as appurtement to 2.0 acres in NE<sup>+</sup><sub>2</sub> NE<sup>+</sup><sub>2</sub>, 19.0 acres in SE<sup>+</sup><sub>2</sub> NE<sup>+</sup><sub>2</sub>, Section 11, and 9.0 acres in SW<sup>+</sup><sub>2</sub> NW<sup>+</sup><sub>2</sub>, Section 12, Township 1 North, Range 4 West, W.M., with a date of priority of December 19, 1938, be severed therefrom and simultaneously and without loss of priority transferred to 14.0 acres in NE<sup>+</sup><sub>2</sub> SE<sup>+</sup><sub>2</sub>, 4.0 acres in SE<sup>+</sup><sub>2</sub> SE<sup>+</sup><sub>3</sub>, Section 11, and 12.0 acres in NW<sup>+</sup><sub>2</sub> SW<sup>+</sup><sub>3</sub>, Section 12, Township 1 North, Range 4 West, W.M.

It is FURTHER ORDERED that said water so transferred shall be applied to beneficial use on or before October 1, 1975.

It is FURTHER ORDERED that no new certificate be issued as provided by the order entered March 27, 1975, and upon receipt of proof satisfactory to the State Engineer of application of water to beneficial use, a certificate of water right shall be issued confirming the extent to which the water has been applied beneficially.
