ORDER APPROVING TRANSFER NO. 2707

On September 15, 1972, M.R.S. Company, Inc., filed an application in the office of the Water Resources Director for the approval of a change in place of use of water from Deschutes River, pursuant to the provisions of ORS 540.510 to 540.530.

By Decree of the Circuit Court for Deschutes County, Oregon, entered September 30, 1958, In the Matter of the Determination of the Relative Rights to the Use of the Deschutes River and its Tributaries, a water right was established in the name of Central Oregon Irrigation District for the use of the waters of Deschutes River for the irrigation of, among other lands, 14.0 acres in SE4 SW4 and 6.0 acres in SW4 SE4, Section 27, Township 17 South, Range 12 East, W.M., being tabulated in the name of H. F. Cosswhite, as evidenced by certificate of water right recorded at Page 29052, Volume 21, State Record of Water Right Certificates. An order of the State Engineer, entered October 31, 1969, approved a change in place of use for irrigation of 2.0 acres in SW2 SE2, Section 27, Township 17 South, Range 12 East, W.M. Evidence satisfactory to the Water Resources Director of beneficial use of water has been submitted. These rights have dates of priority of October 31, 1900, and December 2, 1907. These lands also have a supplemental right under permit No. 23256 to the use of the water stored in Crane Prairie Reservoir with a date of priority of February 28, 1913.

The applicant herein, owner of the land above described, proposes to transfer the water right therefrom, without loss of priority, to 10.0 acres in SE¹/₄ NE¹/₄, Section 32, 6.0 acres in SW¹/₄ NW¹/₄, 5.0 acres in NE¹/₄ SW¹/₄, Section 33, Township 17 South, Range 13 East, W.M., and 1.0 acre in NW¹/₄ NE¹/₄, Section 33, Township 17 South, Range 14 East, W.M.

Notice by publication as provided by ORS 540.520 was not given in connection with this application for the reason that said section provides notice is not required on an application for a change in place of use of water.

The lands involved herein are within the boundaries of the Central Oregon Irrigation District and the Board of Directors of said District approved the proposed change in place of use of water at a regular meeting held July 5, 1972.

No objection having been filed and it appearing that the proposed change in place of use may be made without injury to existing rights, the application should be approved.

NOW, THEREFORE, it hereby is ORDERED that the change in place of use of water is approved and the water right hereinbefore described as appurtenant to 14.0 acres in SE¹/₄ SW¹/₄ and 8.0 acres in SW¹/₄ SE¹/₄, Section 27, Township 17 South, Range 12 East, W.M., with a date of priority of October 31, 1900, and December 2, 1907, be severed therefrom and simultaneously and without loss of priority transferred to 10.0 acres in SE¹/₄ NE¹/₄, Section 32, 6.0 acres in SW¹/₄ NW¹/₄, 5.0 acres in NE¹/₄ SW¹/₄, Section 33, Township 17 South, Range 13 East, W.M., and 1.0 acre in NW¹/₄ NE¹/₄, Section 33, Township 17 South, Range 14 East, W.M.

It is FURTHER ORDERED that said water so trasnferred shall be applied to beneficial use on or before October 1, 1977.

It is FURTHER ORDERED that upon receipt of proof satisfactory to
the Water Resources Director of complete application of water to beneficial

ORDER AMENDING ORDER APPROVING TRANSFER 2707

On September 15, 1972, M.R.S. Company, Incorporated filed an application in the office of the Water Resources Director for the approval of a change in place of use of water from Deschutes River, pursuant to the provisions of ORS 540.150 to 540.530.

The order of the Water Resources Director entered on July 27, 1976 at page 357, Volume 27, approving said change, allowed a change in place of use of water to 1.0 acre in NW 1/4 NE 1/4, Section 33, Township 17 South, Range 14 East, WM. The actual proposed place of use is within NE 1/4 NW 1/4 of said Section, as attested by letter dated September 8, 1983, from Robert A. Anderson, Assistant Manager, Central Oregon Irrigation District. District records, on approval of Transfer 2707, placed the 1.0 acre water right upon the property of William Spatz, within NE 1/4 NW 1/4, Section 33, Township 17 South, Range 14 East, WM. Water has been applied to said 1.0 acre since said order was issued.

NOW THEREFORE, it hereby is ORDERED that the aforesaid order be amended to place 1.0 acre in NE 1/4 NW 1/4, Section 33, Township 17 South, Range 14 East, WM, and to delete 1.0 acre from NW 1/4 NE 1/4 of said Section.
