

ORDER APPROVING TRANSFER NO. 2820

On May 24, 1973, Madeline Lackner filed an application in the office of the State Engineer for the approval of a change in point of diversion of water from Bilyeu Creek, pursuant to the provisions of ORS 540.510 to 540.530.

Certificate of water right issued to Madeline Lackner and recorded at page 32468, Volume 24, State Record of Water Right Certificates, confirms a right to the use of not to meed 0.34 cubic foot per second of water from Bilyeu Creek for the irrigation of 11.4 acres in SW2 SE2, 12.9 acres in SE2 SE2, Section 9, 10.1 acres in NE2 NE2, and 9.4 acres in NW2 NE2, Section 16, Township 10 South, Range 1 East, W.M., with a date of priority of April 2, 1959. These lands are irrigated from a point of diversion located 425 feet North and 1225 feet East from the Northeast corner of Bilyeu D.L.C. #39, being within the SW2 SE2, Section 9, Township 10 South, Range 1 East, W.M.

The applicant herein, owner of the lands above described, proposes to irrigate these lands from a point of diversion to be located 150 feet North and 400 feet East from the Northeast corner of Bilyeu D.L.C. #39, being within the SW¹/₄ SE¹/₄, Section 9, Township 10 South, Range 1 East, W.M.

Notice of the filing of the application was given by publication setting forth a time and place certain for hearing objections to the proposed change in point of diversion of water, if any there were, namely: at the county courthouse in Albany, Oregon on January 2, 1974 at 9:30 a.m.

The notice was published in the Scio Tribune, a newspaper printed and having general circulation in the Linn County, Oregon, for a period of three weeks in the issues of November 8, 15 and 22, 1973. The date set for hearing in said notice was not less than thirty days after the last publication of the notice.

Mr. Gene McGinnis, Watermaster of District No. 2, has filed a report to the effect that the proposed change in point of diversion of water may be made without injury to existing rights.

No objections having been filed and it appearing that the proposed change in point of diversion may be made without injury to existing rights, the application should be approved.

NOW, THEREFORE, it hereby is ORDERED that the change in point of diversion of water from Bilheu Creek, to wit:

From a point located 425 feet North and 1225 feet East from the Northeast corner of Bilyeu D.L.C. #39, being within the SW1 SE1 of Section 9, Township 10 South, Range 1 East, W.M.

To a point to be located 150 feet North and 400 feet East from the Northeast corner of Bilyeu D.L.C. #39, being within the SW2 SE2 of Section 9, Township 10 South, Range 1 East, W.M.

for the irrigation of 11.4 acres in SW2 SE2, 12.9 acres in SE2 SE2, Section 9, 10.1 acres in NE2 NE2, and 9.4 acres in NW2 NE2, Section 16, Township 10 South, Range 1 East, W.M., with a date of priority of April 2, 1959, is approved.

It is FURTHER ORDERED that the construction work shall be completed and the change in point of diversion of water made on or before October 1, 1974.

It is FURTHER ORDERED that the quantity of water diverted at the new point of diversion shall not exceed the quantity of water available at the old point of diversion, and shall not exceed 0.54 cubic foot per second.

It is FURTHER ORDERED that the following provisions shall be effective when in the judgement of the watermaster it becomes necessary to install headgates and measuring devices.

That the diversion works shall include an in line flow meter, a weir, or other suitable device for measuring the water to which the applicant is entitled.

That the type and plans of the measuring device be approved by the watermaster before the beginning of construction work and that the weir or measuring device be installed under the general supervision of said watermaster.

It is FURTHER ORDERED that certificate of water right heretofore issued to Madeline Lackner and recorded at page 32468, Volume 24, State Record of Water Right Certificates, is canceled, and upon receipt of proof satisfactory to the State Engineer of completion of the authorized change in point of diversion, a certificate of water right shall be issued to Madeline Lackner confirming the change in point of diversion.
