

ORDER APPROVING TRANSFER NO. 2920

On November 13, 1973 Orren Brownson, Yolanda M. desBrisey and Weldell Gray filed an application in the office of the State Engineer for the approval of a change in point of diversion of water from Little Luckiamute River, pursuant to the provisions of ORS 540.510 to 540.530.

Certificate of water right issued to Howard V. Morgan and recorded at page 24193, Volume 17, State Record of Water Right Certificates, confirms a right to the use of not to exceed 0.94 cubic foot per second of water from the Little Luckianute River for the irrigation of 3.2 acres in NW_4^1 NE_2^1 , 20.5 acres in SW_4^1 NE_4^1 , 2.5 acres in NE_4^1 NW_4^1 , 16.5 acres in SE_4^1 NW_4^1 , 1.5 acres in NE_4^1 SW_4^1 , 1.0 acres in SE_4^1 SW_4^1 , 5.0 acres in NE_4^1 SE_4^1 , 22.5 acres in NW_4^1 SE_4^1 and 2.8 acres in SW_4^1 SE_4^1 , Section 9, Township 9 South, Range 5 West, W.M., with a date of priority of September 24, 1948. These lands are irrigated from a point of diversion located 1000 feet North and 3175 feet East from the SW corner of Section 9, being within the SW_4^1 SE_4^1 of Section 9, Township 9 South, Range 5 West, W.M.

The applicant herein, owner of the lands above described, proposes to divert the water for irrigation from a point located 1150 feet North and 3700 feet East from the SW corner of Section 9, being within the SW_4^1 SE¹/₄ of Section 9, Township 9 South, Range 5 West, W.M.

Notice by publication as provided by ORS 540.520 was not given in connection with this application for the reason said Section provides notice is not required on an application for a change in point of diversion of water of less than one-fourth mile where there are no intervening diversions. Mr. Leon McGinnis, Watermaster of District No. 2, has filed a report to the effect that the proposed change in point of diversion may be made without injury to existing rights.

No objections having been filed and it appearing that the proposed change in point of diversion may be made without injury to existing rights, the application should be approved.

NOW, THEREFORE, it hereby is ORDERED that the proposed change in point of diversion of water from Little Luckiamute River, to-wit:

> From a point located 1000 feet North and 3175 feet East from the SW corner of Section 9, being within the SW_{\pm}^{1} SE_{\pm}^{1} of Section 9, Township 9 South, Range 5 West, W.M.

To a point to be located 1150 feet North and 3700 feet East from the SW corner of Section 9, being within the SW_4^1 SE_4^1 of Section 9, Township 9 South, Range 5 West, W.M.

for the irrigation of 3.2 acres in NW¹/₄ NE¹/₄, 20.5 acres in SW¹/₄ NE¹/₄, 2.5 acres in NE¹/₄ NW¹/₄, 16.5 acres in SE¹/₄ NW¹/₄, 1.5 acres in NE¹/₄ SW¹/₄, 1.0 acres in SE¹/₄ SW¹/₄, 5.0 acres in NE¹/₄ SE¹/₄, 22.5 acres in NW¹/₄ SE¹/₄ and 2.8 acres in SW¹/₄ SE¹/₄, Section 9, Township 9 South, Range 5 West, W.M., with a date of priority of September 24, 1948, is approved.

The applicant reports that the change in point of diversion has been made so no time limit need be fixed.

It is FURTHER ORDERED that the quantity of water diverted at the new point of diversion shall not exceed the quantity of water available at the old point of diversion, and shall not exceed. 0.94 cubic foot per second.

It is FURTHER ORDERED that the following provisions shall be effective when in the judgement of the watermaster it becomes necessary to install headgates and measuring devices.

> That the diversion works shall include an in-line flow meter, a weir, or other suitable device for measuring the water to which the applicant is entitled.

> That the type and plans of the measuring device be approved by the watermaster before the beginning of construction work and that the weir or measuring device be installed under the general supervision of said watermaster.

It is FURTHER ORDERED that certificate of water right heretofore issued to Howard V. Morgan and recorded at page 24193, Volume 17, State Record of Water Right Certificates is canceled and upon receipt of proof satisfactory to the State Engineer of completion of the authorized change in point of diversion a certificate of water right shall be issued to Orren Brownson, Yolanda M. desBrisey and Wendell Gray confirming said change in point of diversion.
