IN THE MATTER OF THE APPLICATION OF WILLIAM J. DAHLSEID FOR THE APPROVAL OF A CHANGE IN PLACE OF USE OF WATER FROM A WELL

ORDER APPROVING TRANSFER NO. 3285

On July 23, 1975, William J. Dahlseid filed an application in the office of the Water Resources Director for the approval of a change in place of use of water from a well, pursuant to the provisions of ORS 540.510 to 540.530.

Certificate of water right issued to William J. Dahlseid and recorded at page 41675, Volume 33, State Record of Water Right Certificates, confirms a right to the use of not to exceed 0.13 cubic foot por second of water from a well for the irrigation of, among other lands, 9.4 acres in SW¹/₂ SW¹/₂, Section 30, Township 5 South, Range 1 East, W.M., with a date of priority of February 3, 1969. These lands are irrigated from a well located 200 feet North and 660 feet East from the Southwest corner of Section 30, being within the SW¹/₂ SW¹/₂ of Section 30, Township 5 South, Range 1 East, W.M.

The applicant herein, owner of the land above described, proposes to transfer the water right therefrom, without loss of priority, to 3.4 acres in NW2 SW2 and 6.0 acres in SW2 SW2, Section 30, Township 5 South, Range 1 East, W.M.

Notice by publication as provided by ORS 540.520 was not given in connection with this application for the reason that said section provides notice is not required on an application for a change in place of use of water.

Mr. Keith Falmer, Watermaster of District No. 16, has filed a statement to the effect that the proposed change in place of use of water may be made without injury to existing rights. No objections having been filed and it appearing that the proposed change in place of use may be made without injury to existing rights, the application should be approved.

NOW, THEREFORE, it hereby is ORDERED that the change in place of use of water is approved and the water right hereinbefore described as appurtement to 2.4 acres in SW2 SW2, Section 30, Township 5 South, Range 1 East, W.M., with a date of priority of February 3, 1969, be severed therefrom and simultaneously and without loss of priority transferred to 3.4 acres in NW2 SW2 and 6.0 acres in SW2 SW2, Section 30, Township 5 South, Range 1 East, W.M.

It is FURTHER ORDERED that said water so transferred shall be applied to beneficial use on or before October 1, 1976.

It is FURTHER ORDERED that certificate of water right heretofore issued to William J. Dahlseid and recorded at page 41675, Volume 33, State Record of Water Hight Certificates, is canceled, and upon receipt of proof satisfactory to the Water Resources Director of application of water to beneficial use, a certificate of water right shall be issued to William J. Dahlseid confirming the extent to which the water has been applied beneficially and including the balance of the right not involved in this proceeding. Dear Mr. Dahlseid:

The order of the Water Resources Director entered on November 5, 1975, approving your water right transfer application No. 3285, authorized a change in place of use of water from a well located 200 feet North and 660 feet East from the Southwest corner of Section 30, being within the SW4 SW4 of Section 30, Township 5 South, Range 1 East, W.M., to irrigate a certain 3.4 acres in NW4 SW4 and 6.0 acres in SW4 SW4 of said Section 30, with a date of priority of February 3, 1969. Under the provisions of the order, the time in which to fully accomplish the change in place of use of water expired on October 1, 1976.

On the basis of information obtained by a field inspection of the lands by representatives of this office on July 22, 1977, it appears that the 9.4 acres of land described in your transfer application No. 3235 are not being irrigated from the well as authorized by the order and, therefore, the water right, as described above, is no longer valid.
