ORDER APPROVING
TRANSFER NO. 2630

On April 18, 1972, Leland G. Klukkert filed an application in the office of the State Engineer for the approval of a change in place of use of water from Squaw Creek, pursuant to the provisions of ORS 540.510 to 540.530.

By Decree of the Circuit Court for Deschutes County, Oregon, entered May 1, 1911, In the Matter of the Determination of the Relative Rights to the Use of the Waters of Squaw Creek and its Tributaries, a water right was established in the name of Jessie Winters for the irrigation of, among other lands, 5.0 acres in NW $\frac{1}{4}$ NW $\frac{1}{4}$, Section 18, Township 15 South, Range 11 East, W.M., with a date of priority of November 11, 1895, as evidenced by certificate of water right recorded at page 302, Volume 1, State Record of Water Right Certificates.

The applicant herein, owner of the lands above described proposes to transfer the water right therefrom, without loss of priority to 5.0 acres in NW $\frac{1}{4}$ NE $\frac{1}{4}$, Section 18, Township 15 South, Range 11 East, W.M.

Notice by publication as provided by ORS 540.520 was not given in connection with this application for the reason that said section provides notice is not required on an application for a change in place of use of water.

The lands involved herein are within the boundaries of the Squaw Creek Irrigation District and the Board of Directors of said District approved the proposed change in place of use of water.

No objections having been filed and it appearing that the proposed change in place of use of water may be made without injury to existing rights, the application should be approved.

NOW, THEREFORE, it hereby is ORDERED that the proposed change in place of use of water is approved and the water right hereinbefore described as appurtenant to 5.0 acres in NW $\frac{1}{4}$ NW $\frac{1}{4}$, Section 18, Township 15 South, Range 11 East, W.M., with a date of priority of November 11, 1895, be severed therefrom and simultaneously and without loss of priority transferred to 5.0 acres in NW $\frac{1}{4}$ NE $\frac{1}{4}$, Section 18, Township 15 South, Range 11 East, W.M.

It is FURTHER ORDERED that said water so transferred shall be applied to beneficial use on or before October 1, 1972.

It is FURTHER ORDERED that upon receipt of proof satisfactory to the State Engineer of complete application of water to beneficial use on the lands to which the water is transferred hereby, certificate of water right shall be issued to Squaw Creek Irrigation District at the time certificate is issued to the District confirming other transfers within the District.


LOSS OF RIGHT

Transfer application No. 2630 in the name of Leland G. Klukkert proposed a change in place of use of water from Squaw Creek under a certain water right with a priority date of November 11, 1895, to irrigate a certain 5.0 acres in NW $\frac{1}{4}$ NE $\frac{1}{4}$ of Section 18, Township 15 South, Range 11 East, W.M.

The order of the State Engineer, predecessor of the Water Resources Director, entered on May 1, 1972, approving transfer application No. 2630, provided that the proposed change be completed by October 1, 1972.

The applicant has failed to make proof to the satisfaction of the Water Resources Director that any land was irrigated within the provisions of the order, therefore, the subject water right was lost.
