that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.69 cubic foot per second

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed 2 1/2 acre feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage from reservoir constructed under Permit No. R-1441;

ORDER APPROVING
TRANSFER NO. 3024

On May 1, 1974, Sandy Farms filed an application in the office of the State Engineer for the approval of a change in point of diversion of water from an unnamed stream, tributary to Tickle Creek, pursuant to the provisions of ORS 540.510 to 540.530.

Certificate of water right issued to Sandy Farms and recorded at page 34209, Volume 26, State Record of Water Right Certificates, confirms a right to the use of not to exceed 0.69 cubic foot per second of water from an unnamed stream and reservoir for the irrigation of 2.0 acres in NW $\frac{1}{4}$ NE $\frac{1}{4}$, 39.3 acres in SW $\frac{1}{4}$ NE $\frac{1}{4}$, 30.2 acres in SE $\frac{1}{4}$ NE $\frac{1}{4}$, 38.4 acres in NE $\frac{1}{4}$ NW $\frac{1}{4}$, 31.4 acres in NE $\frac{1}{4}$ SE $\frac{1}{4}$, 11.2 acres in NW $\frac{1}{4}$ SE $\frac{1}{4}$, 0.1 acre in SW $\frac{1}{4}$ SE $\frac{1}{4}$, 4.0 acres in SE $\frac{1}{4}$ SE $\frac{1}{4}$, Section 21, 0.7 acre in SW $\frac{1}{4}$ NW $\frac{1}{4}$, 11.4 acres in NE $\frac{1}{4}$ SW $\frac{1}{4}$, 10.6 acres in NW $\frac{1}{4}$ SW $\frac{1}{4}$, 30.0 acres in SW $\frac{1}{4}$ SW $\frac{1}{4}$, 10.6 acres in SE $\frac{1}{4}$ SW $\frac{1}{4}$, Section 22, and supplemental irrigation of 33.2 acres in SW $\frac{1}{4}$ NW $\frac{1}{4}$, Section 22, all in Township 2 South, Range 4 East, W.M., with a date of priority of October 8, 1952. These lands are irrigated from a point of diversion located 198 feet South and 383 feet West from the East $\frac{1}{4}$ corner of Section 21, being within the NE $\frac{1}{4}$ SE $\frac{1}{4}$, Section 21, Township 2 South, Range 4 East, W.M.

The applicant herein, owner of the lands above described, proposes to irrigate these lands from a point of diversion to be located 145 feet North and 547 feet West, from the East $\frac{1}{4}$ corner of Section 21, being within the SE $\frac{1}{4}$ NE $\frac{1}{4}$, Section 21, Township 2 South, Range 4 East, W.M.

Notice by publication as provided by ORS 540.520 was not given in connection with this application for the reason said Section provides notice is not required on an application for a change in point of diversion of water of less than one-fourth mile where there are no intervening diversions.

Mr. E. Michael Ricks, Watermaster of District No. 16, has filed a report to the effect that the proposed change in point of diversion of water may be made without injury to existing rights.

No objections having been filed and it appearing that the proposed change in point of diversion may be made without injury to existing rights, the application should be approved.

NOW, THEREFORE, it hereby is ORDERED that the change in point of diversion of water from an unnamed stream, tributary of Tickle Creek, to wit:

From a point located 198 feet South and 383 feet West from the East $\frac{1}{4}$ corner of Section 21, being within the NE $\frac{1}{4}$ SE $\frac{1}{4}$ of Section 21, Township 2 South, Range 4 East, W.M.

To a point to be located 145 feet North and 547 feet West from the East $\frac{1}{4}$ corner of Section 21, being within the SE $\frac{1}{4}$ NE $\frac{1}{4}$ of Section 21, Township 2 South, Range 4 East, W.M.

for the irrigation of 2.0 acres in NW $\frac{1}{4}$ NE $\frac{1}{4}$, 39.3 acres in SW $\frac{1}{4}$ NE $\frac{1}{4}$, 30.2 acres in SE $\frac{1}{4}$ NE $\frac{1}{4}$, 38.4 acres in NE $\frac{1}{4}$ NW $\frac{1}{4}$, 31.4 acres in NE $\frac{1}{4}$ SE $\frac{1}{4}$, 11.2 acres in NW $\frac{1}{4}$ SE $\frac{1}{4}$, 0.1 acre in SW $\frac{1}{4}$ SE $\frac{1}{4}$, 4.0 acres in SE $\frac{1}{4}$ SE $\frac{1}{4}$, Section 21, 0.7 acre in SW $\frac{1}{4}$ NW $\frac{1}{4}$, 11.4 acres in NE $\frac{1}{4}$ SW $\frac{1}{4}$, 10.6 acres in NW $\frac{1}{4}$ SW $\frac{1}{4}$, 30.0 acres in SW $\frac{1}{4}$ SW $\frac{1}{4}$, 10.6 acres in SE $\frac{1}{4}$ SW $\frac{1}{4}$, Section 22, and supplemental irrigation of 33.2 acres in SW $\frac{1}{4}$ NW $\frac{1}{4}$, Section 22, all in Township 2 South, Range 4 East, W.M., with a date of priority of October 8, 1952, is approved.

It is FURTHER ORDERED that the construction work shall be completed and the change in point of diversion of water made on or before October 1, 1975.

It is FURTHER ORDERED that the quantity of water diverted at the new point of diversion shall not exceed the quantity of water available at the old point of diversion.

It is FURTHER ORDERED that the following provisions shall be effective when in the judgement of the watermaster it becomes necessary to install headgates and measuring devices.

That the diversion works shall include an in line flow meter, a weir, or other suitable device for measuring the water to which the applicant is entitled.

That the type and plans of the measuring device be approved by the watermaster before the beginning of construction work and that the weir or measuring device be installed under the general supervision of said watermaster.

It is FURTHER ORDERED that certificate of water right heretofore issued to Sandy Farms and recorded at Page 34209, Volume 26, State Record of Water Right Certificates, is canceled and upon receipt of proof satisfactory to the State Engineer of completion of the authorized change in point of diversion, a certificate of water right shall be issued to Sandy Farms confirming the change in point of diversion.
