





ORDER APPROVING TRANSFER NO. 2511

On April 16, 1971, Purman Richey filed an application in the office of the State Engineer for the approval of a change in point of diversion of water from Crabtree Creek, pursuant to the provisions of ORS 540.510 to 540.530.

Certificate of water right issued to James S. and Lois
Kingsberry and recorded at page 23588, Volume 17, State Record of
Water Right Certificates, confirms a right to the use of not to
exceed 0.20 cubic foot per second of water from Crabtree Creek for
the irrigation of, among other lands, 9.5 acres in NWA NWA, Section
18, Township 11 South, Range 1 East, W.M., with a date of priority
of March 24, 1952.

Certificate of water right issued to James S. and Lois
Kingsberry and recorded at page 30002, Volume 22, State Record of
Water Right Certificates, confirms a right to the use of not to exceed 0.28 cubic foot per second of water from Crabtree Creek for the
irrigation of 18.4 acres in SWA NWA and 4.1 acres in SEM NWM, Section
18, Township 11 South, Range 1 East, W.M., with a date of priority of
May 25, 1955.

These lands are irrigated from a point of diversion located 14.5 chains south and 23.5 chains east from the NW corner of Section 18 being within the NE% NW% of Section 18, Township 11 South, Range 1 East, W.M.

The applicant herein, owner of the lands above described, proposes to irrigate these lands from a point of diversion to be

located S 55° 45° E 2980 feet from the NW corner of Section 18 being within the SE% NW% of Section 18, Township 11 South, Range 1 East, W.M.

Notice by publication as provided by ORS 540.520 was not given in connection with this application for the reason said section provides notice is not required on an application for a change in point of diversion of water of less than one-fourth mile where there are no intervening diversions.

Mr. Vestal R. Garner, Watermaster of District No. 2, has filed a report to the effect that the proposed change in point of diversion may be made without injury to existing rights.

No objections having been filed and it appearing that the proposed change in point of diversion may be made without injury to existing rights, the application should be approved.

NOW, THEREFORE, it hereby is ORDERED that the proposed change in point of diversion of water from Crabtree Creek, to-wit:

From a point located 14.5 chains south and 23.5 chains east from the NW corner of Section 18 being within the NE% NW% of Section 18, Township 11 South, Range 1 East, W.M.

To a point to be located S 55° 45° E 2980 feet from the NW corner of Section 18 being within the SE% NW% of Section 18, Township 11 South, Range 1 East, W.M.

for the irrigation of 9.5 acres in NWW NWW, with a date of priority of March 24, 1952, 18.4 acres in SWW NWW and 4.1 acres in SEW NWW, with a date of priority of May 25, 1955, Section 18, Township 11 South, Range 1 East, W.M., is approved.

It is FURTHER ORDERED that the construction work shall be completed and the change in point of diversion of water made on or before October 1, 1972.

It is FURTHER ORDERED that the quantity of water diverted at the new point of diversion shall not exceed the quantity of water

available at the old point of diversion and shall not exceed 0.117 cubic foot per second, with a date of priority of March 24, 1952, and 0.28 cubic foot per second, with a date of priority of May 25, 1955.

It is FURTHER ORDERED that the following provisions shall be effective when in the judgement of the watermaster it becomes necessary to install headgates and measuring devices.

That the diversion works shall include an in-line flow meter, a weir, or other suitable device for measuring the water to which the applicant is entitled.

That the type and plans of the measuring device be approved by the watermaster before the beginning of construction work and that the weir or measuring device be installed under the general supervision of said watermaster.

It is FURTHER DRDERED that the certificates of water right heretofore issued to James S. and Lois Kingsberry and recorded at page 23588, Volume 17, and page 30002, Volume 22, State Record of Water Right Certificates, be canceled and in lieu thereof a new certificate be issued to James S. and Lois Kingsberry covering the balance of the lands not involved in this proceeding and upon receipt of proof satisfactory to the State Engineer of completion of the authorized changes in point of diversion, a certificate of water right shall be issued to Purman Richey confirming the change in point of diversion for the irrigation of the lands under a priority date of March 24, 1952 and a new certificate for the irrigation of the lands under a priority date of May 25, 1955.
