

ORDER APPROVING TRANSFER NO. 3058

On June 3, 1974, Pirfil Cam filed an application in the office of the Water Resources Director for the approval of a change in point of diversion of water from Butte Creek, pursuant to the provisions of ORS 540.510 to 540.530.

Certificate of water right issued to John Clary and recorded at Page 34698, Volume 26, State Record of Water Right Certificates, confirms a right to the use of not to exceed 0.63 cubic foot per second of water from Butte Creek for the irrigation of, among other lands, 5.6 acres in NE¹/₄ NW¹/₄, 28.8 acres in NW¹/₄ NW¹/₄ and 1.2 acres in SW¹/₄ NW¹/₄, Section 8, Township 6 South, Range 1 East, W.M., with a date of priority of May 8, 1963. These lands are irrigated from a point of diversion located 720 feet South and 2080 feet East from the Northwest corner of Section 8, being within the NE¹/₄ NW¹/₄, Section 8, Township 6 South, Range 1 East, W.M.

The applicant herein, contract purchaser of the lands above described, proposes to irrigate these lands from a point of diversion to be located 450 feet South and 1550 feet East from the Northwest corner of Section 8, being within the NE¹/₄ NW¹/₄, Section 8, Township 6 South, Range 1 East, W.M.

John Clary, contract seller of the lands above described, has submitted written approval of the proposed change in point of diversion.

Notice by publication as provided by ORS 540.520 was not given in connection with this application for the reason said section provides notice is not required on an application for a change in point of diversion of water of less than one-fourth mile where there are no intervening diversions.

Mr. Keith Palmer, Watermaster of District No. 16, has filed a report to the effect that the proposed change in point of diversion of water may be made without injury to existing rights.

No objections having been filed and it appearing that the proposed change in point of diversion may be made without injury to existing rights, the application should be approved.

NOW, THEREFORE, it hereby is ORDERED that the change in point of diversion of water from Butte Creek, to wit:

From a point located 720 feet South and 2080 feet East from the Northwest corner of Section 8, being within the NET NWT of Section 8, Township 6 South, Range 1 East, W.M.

To a point to be located 450 feet South and 1550 feet East from the Northwest corner of Section 8, being within the NET NWT of Section 8, Township 6 South, Range 1 East, W.M.

for the irrigation of 5.6 acres in NE2 NW2, 28.8 acres in NW2 NW2 and 1.2 acres in SW2 NW2, Section 8, Township 6 South, Range 1 East, W.M., with a date of priority of May 8, 1963, is approved.

It is FURTHER ORDERED that the construction work shall be completed and the change in point of diversion of water made on or before October 1, 1976.

It is FURTHER ORDERED that the quantity of water diverted at the new point of diversion shall not exceed the quantity of water available at the old point of diversion, and shall not exceed 0.2 cubic foot per second.

It is FURTHER ORDERED that the following provisions shall be effective when in the judgement of the watermaster it becomes necessary to install headgates and measuring devices.

That the diversion works shall include an in line flow meter, a weir, or other suitable device for measuring the water to which the applicant is entitled.

That the type and plans of the measuring device be approved by the watermaster before the beginning of construction work and that the weir or measuring device be installed under the general supervision of said watermaster.
