



PROPOSED CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

PAT PEARMAIN

confirms the right to use the waters of UMPQUA RIVER, a tributary of PACIFIC OCEAN, for the purpose of IRRIGATING 3.0 ACRES.

The right has been perfected under Permit 20139. The date of priority is MARCH 12, 1951. The right is limited to not more than 0.038 CUBIC FOOT PER SECOND, IF AVAILABLE AT THE ORIGINAL POINT OF DIVERSION; NE 1/4 SE 1/4, AS PROJECTED WITHIN DLC 44, SECTION 20, T 23 S, R 7 W, W.M.; 1630 FEET NORTH AND 820 FEET WEST FROM SE CORNER SECTION 20 or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

NE 1/4 SE 1/4, AS PROJECTED WITHIN DLC 44, SECTION 20, T 23 S, R 7 W, W.M.; 1480 FEET NORTH AND 280 FEET WEST FROM SE CORNER SECTION 20.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:



This certificate is issued to confirm a change in POINT OF DIVERSION approved by an order of the Water Resources Director entered SEPTEMBER 14, 1976, and together with certificates 44686, 48647, AND 54785, AND ORDERS APPROVING TRANSFERS 3345 AND 3421, supersedes certificate 40356, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.





On August 11, 1976, James M. Burke filed an application for transfer of water right in the office of the Water Resources Director proposing a change in point of diversion under an existing right of record to appropriate not to exceed 0.038 cubic foot per second of water from Umpqua River with a date of priority of March 12, 1951, at a point of diversion located 1630 feet North and 820 feet West from the Southeast corner of Section 20, being within the NE $\frac{1}{4}$ SE $\frac{1}{4}$ of Section 20, Township 23 South, Range 7 West, W.M., for the irrigation of 3.0 acres in SE $\frac{1}{4}$ SE $\frac{1}{4}$, Section 20, Township 23 South, Range 7 West, W.M., being a portion of the right evidenced by the certificate recorded at Page 40356, Volume 32, State Record of Water Right Certificates.

The applicant herein, proposes to irrigate the above lands from a point of diversion to be located 1215 feet South and 2270 feet East from the center of Section 20, being within the NE $\frac{1}{4}$ SE $\frac{1}{4}$, Section 20, Township 23 South, Range 7 West, W.M.

Mr. M. John Youngquist, Watermaster of District No. 15, has filed a statement to the effect that the proposed change in point of diversion may be made without injury to existing rights.

No objection having been filed and it appearing that the proposed change in point of diversion may be made without injury to existing rights, the application should be approved.

NOW, THEREFORE, it hereby is ORDERED that the requested change in point of diversion is approved.

It is FURTHER ORDERED that the construction work shall be completed and the change in point of diversion of water made on or before October 1, 1977.

It is FURTHER ORDERED that the quantity of water diverted at the new point of diversion shall not exceed the quantity of water available at the old point of diversion, and shall not exceed 0.038 cubic foot per second.

It is FURTHER ORDERED that the following provisions shall be effective when in the judgement of the watermaster it becomes necessary to install head-gates and measuring devices.

That the diversion works shall include an in line flow meter, a weir, or other suitable device for measuring the water to which the applicant is entitled.

That the type and plans of the measuring device be approved by the watermaster before the beginning of construction work and that the weir or measuring device be installed under the general supervision of said watermaster.

On December 5, 1975, an order was entered by the Water Resources Director approving transfer application No. 3180 for a change in point of diversion for part of the right evidenced by the certificate recorded at Page 40356, Volume 32, State Record of Water Right Certificates, and providing for cancelation of the said certificate and issuance of a new certificate describing the balance of the right not involved in the change.

It is FURTHER ORDERED that the part of the right involved in the change authorized herein not be included in the new certificate to be issued as provided by the order of December 5, 1975, and upon receipt of proof satisfactory to the Water Resources Director of completion of the change in point of diversion authorized herein, a certificate shall be issued to James M. Burke confirming the change in point of diversion.







In my telephone conversation this a.m. with Tom Shook I was advised by him to send in this application and mark it for your attention.




