CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

LEON L. EVANS C/O WAGON WHEEL TRAILER PARK 20727 HWY 62 SHADY COVE, OR 97539

confirms the right to use the waters of ROGUE RIVER, a tributary of PACIFIC OCEAN, for IRRIGATING 2.6 ACRES.

This right was perfected under Permit 8572. The date of priority is JULY 5, 1928. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.032 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

ORDER APPROVING TRANSFER NO. 3138

On October 8, 1974, Wayne W. and Elizabeth Eastwood filed an application in the office of the Water Resources Director for the approval of a change in point of diversion of water from Rogue River, pursuant to the provisions of ORS 540.510 to 540.530.

Certificate of water right issued to Thomas J. Johnson and recorded at Page 361h3, Volume 28, State Record of Water Right Certificates, confirms a right to the use of not to exceed 0.16h cubic feet per second of water from Rogue River for the irrigation of, among other lands, 2.6 acres in SE4 NE4, Section 21, Township 3h South, Range 1 West, W. M., with a date of priority of July 5, 1928. These lands are irrigated by means of the Dennis, Johnson and Hall ditch from a point of diversion located 1320 feet North and 800 feet West from the Southeast corner of Section 16, being within the SE4 SE4, Section 16, Township 3h South, Range 1 West, W. M.

The applicant herein, owner of the lands above described, proposes to irrigate these lands from a point of diversion to be located 190 feet North and 1230 feet West from the East quarter-corner of Section 21, being within the SE¹/₄ NE¹/₄, Section 21, Township 31 South, Range 1 West, W. M.

Notice of the filing of the application was given by publication setting forth a time and place certain for hearing objections to the proposed change in point of diversion of water, if any there were, namely: at the County Courthouse in Medford, Oregon, on January 6, 1976 at 1:30 P.M. The notice was published in the Medford Mail Tribune, a newspaper printed and having general circulation in Jackson County, Oregon, for a period of three weeks in the issues of November 10, 17 and 2h, 1975. The date set for hearing in said notice was not less than thirty days after the last publication of the notice.

Mr. David C. Hendrix, Watermaster of District No. 13, has filed a report to the effect that the proposed change in point of diversion of water may be made without injury to existing rights.

for the irrigation of 2.6 acres in SE1 NE1, Section 21, Township 34 South, Range 1 West, W. M., with a date of priority of July 5, 1928, is approved.

It is FURTHER ORDERED that the construction work shall be completed and the change in point of diversion of water made on or before October 1, 1976.

It is FURTHER ORDERED that the quantity of water diverted at the new point of diversion shall not exceed the quantity of water available at the old point of diversion, and shall not exceed 0.032 cubic feet per second.

It is FURTHER ORDERED that the following provisions shall be effective when in the judgement of the watermaster it becomes necessary to install headgates and measuring devices.

That the diversion works shall include an in line flow meter, a weir, or other suitable device for measuring the water to which the applicant is entitled.

That the type and plans of the measuring device be approved by the watermaster before the beginning of construction work and that the weir or measuring device be installed under the general supervision of said watermaster.

It is FURTHER ORDERED that the certificate of water right heretofore issued to Thomas J. Johnson and recorded at Page 36143, Volume 28,
State Record of Water Right Certificates, is canceled, and in lieu thereof
a new certificate be issued covering the balance of the lands not involved
in this proceeding, and upon receipt of proof satisfactory to the Water
Resources Director of completion of the authorized change in point of
diversion, a certificate of water right shall be issued to Wayne W. and
Elizabeth Eastwood confirming the change in point of diversion.
