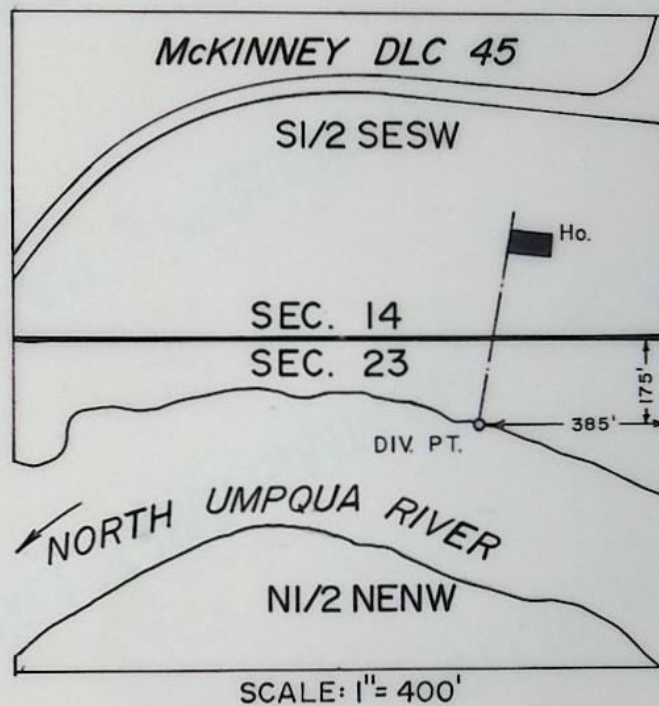

## CERTIFICATE OF WATER RIGHT

This is to certify, That DALE HALL

of PO Box 604, Winchester, State of OR 97495, has made  
proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of  
North Umpqua River

a tributary of Umpqua River for the purpose of  
irrigation of 1.5 acres

under Permit No. 28837 and that said right to the use of said waters has been perfected in  
accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from  
May 13, 1963

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is  
limited to an amount actually beneficially used for said purposes, and shall not exceed

0.02 cubic foot per second, if available at the original point of diversion;  
SW 1/4 SE 1/4, as projected within McKinney DLC 45, Section 14, T26S, R6W, WM;  
2550 feet South and 2620 feet West from E 1/4 corner Section 14  
or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of  
diversion is located in the NE 1/4 NW 1/4, as projected within McKinney  
DLC 45, Section 23, T26S, R6W, WM; 175 feet South and 385 feet West from NE  
corner NE 1/4 NW 1/4, Section 23.

The amount of water used for irrigation, together with the amount secured under any other right  
existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per  
acre,  
or its equivalent for each acre irrigated and shall be  
further limited to a diversion of not to exceed 2.5 acre-feet per acre for  
each acre irrigated during the irrigation season of each year, provided  
further that the right to the use of water is limited to the period when the  
flow of the North Umpqua River is 525 cubic feet per second or more at its  
mouth,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is  
appurtenant, is as follows:

This certificate is issued to confirm a change in point of diversion approved  
by an order of the Water Resources Director entered February 15, 1977, and

Volumes 37 & 42, State Record of Water Right Certificates, supersedes  
certificate 43554.

The issuance of this superseding certificate does not confirm the status of  
the water right in regard to the provisions of ORS 540.610 pertaining to  
forfeiture or abandonment.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use  
herein described and is subject to minimum flows established by the Water Resources Commission with an  
effective date prior to this right.

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.66 cubic feet per second

The point of diversion is located in the SW $\frac{1}{4}$  SE $\frac{1}{4}$ , as projected within McKinney DLC 45, Section 14, T. 26 S., R. 6 W., W. The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year; provided further that the right to the use of water is limited to the period when the flow of the North Umpqua River is 525 c.f.s. or more at its mouth;

ORDER APPROVING  
TRANSFER NO. 3626

On April 13, 1977, an application was filed in the office of the Water Resources Director by Dale W. Hall for a change in point of diversion under an existing water right of record, pursuant to the provisions of ORS 540.510 to 540.530.

The certificate recorded at page 43354, Volume 35, State Record of Water Right Certificates, in the name of G. H. Harrell, describes a right which includes the use of not to exceed 0.02 cubic foot per second from North Umpqua River for irrigation of 1.38 acres in SE $\frac{1}{4}$  SW $\frac{1}{4}$  of Section 14 and 0.12 acre in NE $\frac{1}{4}$  NW $\frac{1}{4}$  of Section 23, Township 26 South, Range 6 West, W.M., with a date of priority of May 13, 1963.

Water for the said right is diverted from a point located 2550 feet South and 2620 feet West from the East quarter corner of Section 14, being within the SW $\frac{1}{4}$  SE $\frac{1}{4}$  of Section 14, Township 26 South, Range 6 West, W.M.

The applicant herein, owner of the lands above described, proposes to change the point of diversion therefrom, without loss of priority, to a point located 90 feet South and 280 feet West from the North quarter corner of Section 23, being within the NE $\frac{1}{4}$  NW $\frac{1}{4}$  of Section 23, Township 26 South, Range 6 West, W.M.

Mr. M. John Youngquist, Watermaster, has filed a statement to the effect that the proposed change in point of diversion may be made without injury to existing rights.

No objections having been filed and it appearing that the proposed change in point of diversion may be made without injury to existing rights, the application should be approved.

NOW, THEREFORE, it hereby is ORDERED that the requested change in point of diversion as described herein, without loss of priority, is approved.

It is FURTHER ORDERED that the quantity of water diverted at the new point of diversion shall not exceed the quantity of water available at the old point of diversion under the subject right, and shall not exceed 0.02 cubic foot per second.

It is FURTHER ORDERED that the following provisions shall be effective when in the judgement of the watermaster it becomes necessary to install headgates and measuring devices:

That the diversion works shall include an in line flow meter, a weir, or other suitable device for measuring the water to which the applicant is entitled:

That the type and plans of the measuring device be approved by the watermaster before the beginning of construction work and that the weir or measuring device be installed under the general supervision of said watermaster.

It is FURTHER ORDERED that the construction work shall be completed and the change in point of diversion of water made on or before October 1, 1979.

It is FURTHER ORDERED that the portion of the right involved in the change authorized herein NOT be included in the new certificate to be issued as provided by the order entered February 15, 1977, approving transfer application No. 3482, and upon receipt of proof satisfactory to the Water Resources Director of completion of the change in point of diversion authorized herein, a certificate of water right shall be issued to the applicant herein confirming the change in point of diversion.
