



On May 26, 1977, an application was filed in the office of the Water Resources Director by Rube W. and Sargie Jones Evans for approval of changes in place of use and point of diversion from John Day River, pursuant to the provisions of ORS 540.510 to 540.530.

The certificate recorded at page 10952, Volume 10, State Record of Water Right Certificates, in the name of Charles R. Chapman, describes a right for the use of not to exceed 1.0 cubic foot per second from John Day River for irrigation of 30.0 acres in NE¹/₄ NE¹/₄, 20.0 acres in NW¹/₄ NE¹/₄, 10.0 acres in SW¹/₄ NE¹/₄ and 10.0 acres in SE¹/₄ NE¹/₄ of Section 32, Township 7 South, Range 19 East, W.M., with a date of priority of May 28, 1927.

Water for the said right is diverted from a point located 1485 feet South and 825 feet East from the North Quarter Corner of Section 32, being within the SW_4^1 NE $_4^1$ of said Section 32.

The applicants herein, owners of the lands above described, propose to change the place of use and point of diversion therefrom and, without loss of priority, to irrigate in lieu thereof a certain 23.5 acres in NE¼ NE¼ and 0.4 acre in SE¼ NE¼ of Section 32; 14.7 acres in NE¼ NW¼, 28.2 acres in NW¼ NW¼, 1.6 acres in SW¼ NW¼ and 1.6 acres in SE¼ NW¼ of Section 33, Township 7 South, Range 19 East, W.M., from a point of diversion located 2650 feet South and 990 feet East from the North Quarter Corner of Section 32, being within the SW¼ NE¼ of said Section 32.

Water for the said right is diverted from a point located 2,550 feet South and 1,000 feet East from the North Quarter Corner of Section 32, being within the SW 1/4 NE 1/4 of Section 32, Township 7 South, Range 19 East, WM.

The applicant herein, owner of the lands above described, proposes to sever the right therefrom and, without loss of priority, to irrigate in lieu thereof 12.5 acres in NE 1/4 NE 1/4, 9.2 acres in NW 1/4 NE 1/4, 3.8 acres in SW 1/4 NE 1/4 and 3.8 acres in SE 1/4 NE 1/4, Section 32, Township 7 South, Range 19 East, WM.

Jerry S. Rodgers, Watermaster, has filed a statement to the effect that the proposed change in place of use may be made without injury to existing rights.

No objections having been filed and it appearing that the proposed change in place of use may be made without injury to existing rights, the application should be approved.

NOW, THEREFORE, it hereby is ORDERED that the requested change in place of use, as described herein, without loss of priority, is approved.

It is FURTHER ORDERED that said water so transferred shall be applied to beneficial use on or before October 1, 1983.

It is FURTHER ORDERED that a certificate be issued covering the balance of the right NOT involved in this proceeding; and upon proof satisfactory to the Water Resources Director of completion of works and beneficial use of water to the extent intended under the provisions of this order, a confirming certificate of water right shall be issued to the applicant herein.

Water for the said right is diverted from a point located 2550 feet South and 1000 feet East from the North Quarter Corner of Section 32, being within the SW 1/4 NE 1/4 of Section 32, Township 7 South, Range 19 East, WM.

Water Right Transfer 4751 subsequently changed the place of use to 13.7 acres in NE 1/4 NW 1/4, 14.0 acres in NW 1/4 NW 1/4 and 1.6 acres in SE 1/4 NW 1/4, Section 33, Township 7 South, Range 19 East, WM.

Pursuant to the provisions of ORS 540.510 to 540.530, proof has been made to the satisfaction of the Water Resources Director that a transfer has been completed under the terms of Transfer 3686 in the names of Bruce and Gloria Lighthart, for the use of not to exceed 0.42 cubic foot per second from John Day River, for irrigation of 13.7 acres in NE 1/4 NW 1/4, 14.0 acres in NW 1/4 NW 1/4 and 1.6 acres in SE 1/4 NW 1/4, Section 33, Township 7 South, Range 19 East, WM, with a date of priority of May 28, 1927.

Water for the said right is diverted from a point located 2550 feet South and 1000 feet East from the North Quarter Corner of Section 32, being within the SW 1/4 NE 1/4 of Section 32, Township 7 South, Range 19 East, WM.

Water Right Transfer 4752 subsequently changed the place of use to 12.5 acres in NE 1/4 NE 1/4, 9.2 acres in NW 1/4 NE 1/4, 3.8 acres in SW 1/4 NE 1/4 and 3.8 acres in SE 1/4 NE 1/4, Section 32, Township 7 South, Range 19 East, WM.

The applicant herein, owner of the lands above described, proposes to change the point of diversion therefrom to a point located 70 feet South and 990 feet East from the North Quarter Corner of Section 32, being within the NW 1/4 NE 1/4 of Section 32, Township 7 South, Range 19 East, WM.

Notice of the application, pursuant to ORS 540.520(2), was published in the Times-Journal, a newspaper printed and having general circulation in Wheeler County, Oregon, for a period of three weeks in the issues of July 14, 21 and 28, 1983.

Jerry S. Rodgers, Watermaster, has filed a statement to the effect that the proposed change in point of diversion may be made without injury to existing rights.

No objections having been filed and it appearing that the proposed change in point of diversion may be made without injury to existing rights, the application should be approved.

NOW, THEREFORE, it hereby is ORDERED that the proposed change in point of diversion is approved, without loss of priority.

It is FURTHER ORDERED that the quantity of water diverted at the new point of diversion shall not exceed the quantity of water available at the old point of diversion under the subject right, and shall not exceed 1.15 cubic foot per second.

It is FURTHER ORDERED that the following provisions shall be effective when in the judgment of the Watermaster it becomes necessary to install headgates and measuring devices:

> That the diversion works shall include an in line flow meter, a weir, or other suitable device for measuring the water to which the applicant is entitled;

> That the type and plans of the measuring device be approved by the watermaster before the beginning of construction work and that the weir or measuring device be installed under the general supervision of said watermaster.

It is FURTHER ORDERED that the construction work shall be completed and water used from the proposed point of diversion on or before October 1, 1985.

It is FURTHER ORDERED that upon proof satisfactory to the Water Resources Director of completion of works and beneficial use of water to the extent intended under the provisions of this order, a confirming certificate of water right shall be issued to the applicant herein.


