1. For irrigation calculate cfs for each water right involved as follows:
 - a. Divide total authorized cfs by total acres in the water right (*for C12345, 1.25 cfs ÷ 100 ac*); then multiply by the number of acres to be transferred to get the transfer cfs (*x 45 ac = 0.56 cfs*).
 - b. If the water right certificate does not list total cfs, but identifies the allowable use as 1/40 or 1/80 of a cfs per acre; multiply number of acres proposed for change by either 0.025 (1/40) or 0.0125 (1/80). (*For C87654, 45.0 ac x 0.0125 cfs/ac = 0.56 cfs*)
2. 




1. **Trust.** The Splawn Family Trust (also known as Splawn Joint Trust) ("Trust") was executed on August 9, 2006 under the laws of the State of Oregon and is presently in existence.
2. **Settlors and Trustees.** The Settlers of the Splawn Family Trust are Edward B. Splawn and Neva D. Splawn. Edward B. Splawn died May 14, 2011. Neva D. Splawn is the sole surviving Settlor. Neva D. Splawn, Marsha A. Masengil, and Benjamin T. Masengil are currently acting as co-Trustees of the Splawn Family Trust.
3. **Trustees' Mailing Address.** 29609 McMullen Lane, Junction City, Oregon 97448
4. **Trust Powers.** The Trustees are given powers granted a trustee under ORS 130.720 and ORS 130.725, including the right to sell, exchange, assign, lease, encumber, or otherwise alienate all or any part of the Trust on such terms as the Trustees shall determine.
5. **Trust Revocable.** The Trust is revocable, modifiable, and amendable by the surviving Settlor.
6. **Multiple Trustees.** The co-Trustees each have authority to exercise Trust powers alone.
7. **Successor Trustee.** In the event of the resignation, incapacity, or death of Neva D. Splawn, Marsha A. Masengil, and/or Benjamin T. Masengil, the survivor(s) of them may continue to serve as Trustee alone.

9. **Title to Trust Property.** Trust property may be titled as follows:


