

The applicants herein, owners of the lands above described, propose to change the place of use to 2.5 acres in NW4 NE4, 1.1 acres in SW4 NE4, 6.4 acres in NE4 NW4, 1.2 acres in NW4 NW4, 13.1 acres in SW4 NW4, 17.4 acres in SE4 NW4, Section 28; 3.7 acres in SE4 NE4 and 3.6 acres in NE4 SE4, Section 29, Township 34 South, Range 1 West, W.M., and to irrigate these lands, together with 4.4 acres in SW4 SE4, Section 21, 4.0 acres in NW4 NE4, 10.2 acres in SW4, 7.1 acres in SE4 NW4, 0.5 acre in NW4 SW4, Section 28; 11.3 acres in SE4 NE4, 10.0 acres in NE4 SE4 and 8.5 acres in SE4 SE4, Section 29, Township 34 South, Range 1 West, W.M., from four points of diversion

Notice of the filing of the application was given by publication setting forth a time and place certain for hearing objections to the proposed change in place of use and point of diversion of water, if any there were, namely: at the county courthouse in Medford, Oregon, on October 22, 1974, at 9:30 a.m. The notice was published in the Medford Mail Tribume, a newspaper printed and having general circulation in Jackson County, Oregon, for a period of three weeks in the issues of August 29, September 5 and September 12, 1974. The date set for hearing in said notice was not less than thirty days after the last publication of the notice.

Mr. David C. Hendrix, Watermaster of District No. 13, has filed a report to the effect that the proposed change in place of use and points of diversion may be made without injury to existing rights.

No objections having been filed and it appearing that the proposed change in place of use and point of diversion may be made without injury to existing rights, the application should be approved.
