



On January 15, 1979, an application was filed in the office of the Water Resources Director by LaVern Partlow for approval of a change in place of use of water from Umatilla River under an existing right of record, pursuant to the provisions of ORS 540.510 to 540.530.

The certificate recorded at page 10142, Volume 9, State Record of Water Right Certificates, in the name of United States Reclamation Service, describes a right which includes the use of water from Umatilla River for irrigation of a certain 12.0 acres in SW<sup>1</sup><sub>4</sub> NW<sup>1</sup><sub>4</sub> and 12.0 acres in SE<sup>1</sup><sub>4</sub> NW<sup>1</sup><sub>4</sub> of Section 24, Township 4 North, Range 24 East, W.M., with a date of priority of March 28, 1909.

These lands also have a supplemental right under permit No. 7400 to the use of water stored in McKay Reservoir with a date of priority of July 1, 1924, and a supplemental right under permit No. 33883 to the use of water from Columbia River with dates of priority of September 12, 1968 and February 26, 1969.

Water for the said right to the use of water from Umatilla River is diverted, through the West Extension Irrigation Canal, from a point located 1000 feet North and 500 feet East from the Southwest Corner of Section 28, being within the SWA SWA of Section 28, Township 5 North, Range 28 East, W.M.

The applicant herein, owner of the lands above described, proposes to transfer the water rights therefrom, without loss of priority, and in lieu thereof to irrigate a certain 12.0 acres in  $NE_4^1$  SW<sub>4</sub> and 12.0 acres in  $NW_4^1$  SW<sub>4</sub> of Section 24, Township 4 North, Range 24 East, W.M.

The lands involved herein are within the boundaries of the West Extension Irrigation District and the Board of Directors of said District approved the proposed change in place of use of water at a regular meeting held June 12, 1975.

No objections having been filed and it appearing that the proposed change in place of use of water may be made without injury to existing rights, the application should be approved.

It is FURTHER ORDERED that said water so transferred shall be applied to beneficial use on or before October 1, 1980.


