

CERTIFICATE OF WATER RIGHT

This Is to Certify, That DR. C. J. MOSER

of 124 NW Midland Avenue, Grants Pass, State of 97526, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Little Luckiamute River

a tributary of Luckiamute River irrigation of 61.5 acres

for the purpose of

under Permit No. 31286 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from January 17, 1966

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed **0.77 cubic foot per second**

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 2 (NW% SW%), Section 31, T. 8 S., R. 5 W., W. M., 2330 feet North and 80 feet East from SW Corner, Section 31.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2½ acre feet per acre for each acre irrigated during the irrigation season of each year;

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer. A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows: -

12.5 acres Lot 3 (SW% SW%) 0.3 acre SW% SW% As projected within Bowman DLC 55 Section 31 T. 8 S., R. 5 W., W. M.

> 19.5 acres SEX SEX Section 36 T. 8 S., R. 6 W., W. M.

0.1 acre NW% NW% As projected within Bowman DLC 39 3.0 acres NW% NW% As projected within Jones DLC 52 9.7 acres Lot 1 (NW% NW%) Section 6 T. 9 S., R. 5 W., W. M.

7.7 acres Lot 1 (NE% NE%) 8.7 acres NE% NE% As projected within Jones DLC 38 Section 1 T. 9 S., R. 6 W., W. M.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.

IN THE MATTER OF THE APPLICATION OF J. L. HENDRICKSON FOR APPROVAL OF CHANGES IN PLACE OF USE AND POINT OF DIVERSION OF WATER FROM LITTLE LUCKIAMUTE RIVER

ORDER APPROVING TRANSFER NO. 3543

On February 23, 1977, an application was filed in the office of the Water Resources Director by J.L. Hendrickson for changes in place of use and point of diversion under an existing water right of record, pursuant to the provisions of ORS 540.510 to 540.530.

The certificate recorded at page 41727, Volume 33, State Record of Water Right Certificates, in the name of Dr. C. J. Moser, describes a right which includes the use of not to exceed 0.62 cubic foot per second from Little Luckiamute River for irrigation of 12.8 acres in SW4 SW4 of Section 31, Township 8 South, Range 5 West; 19.5 acres in SE4 SE4 of Section 36, Township 8 South, Range 6 West; 9.8 acres in NW4 NW4 of Section 6, Township 9 South, Range 5 West; and 7.7 acres in NE4 NE4 of Section 1, Township 9 South, Range 6 West, W.M., with a date of priority of January 17, 1966.

Water for the said right is diverted from a point located 2330 feet North and 80 feet East from the Southwest corner of Section 31, being within the NW4 SW4 of Section 31, Township 8 South, Range 5 West, W.M.

The applicant herein, owner of said lands, proposes to sever the right therefrom and, without loss of priority, to irrigate a certain 18.3 acres in SW4; NE4, 16.1 acres in SE4; NE4, 1.0 acre in SE4; NW4, 0.5 acre in NE4; SE4; and 13.9 acres in NW4; SE4; of Section 6, Township 9 South, Range 5 West, W.M., by diversion of water from a point located 1600 feet South and 1000 feet East from the Northwest corner of DLC No. 51, being within the NE4; SW4; of Section 6, Township 9 South, Range 5 West, W.M. Notice of the application, pursuant to ORS 540.510, was published in the Itemizer-Observer, a newspaper printed and having general circulation in Polk County, Oregon, for a period of three weeks in the issues of May 11, 18 and 25, 1977.

Mr. Benjamin E. Monroe, Watermaster, has filed a statement to the effect that the proposed changes in place of use and point of diversion may be made without injury to existing rights.

No objections having been filed and it appearing that the proposed changes in place of use and point of diversion may be made without injury to existing rights, the application should be approved.

NOW, THEREFORE, it hereby is ORDERED that the requested changes in place of use and point of diversion as described herein, without loss of priority, are approved.

It is FURTHER ORDERED that the quantity of water diverted at the new points of diversion shall not exceed the quantity of water available at the old point of diversion under the subject right, and shall not exceed 0.62 cubic foot per second.

It is FURTHER ORDERED that the following provisions shall be effective when in the judgement of the watermaster it becomes necessary to install headgates and measuring devices:

> That the diversion works shall include an in line flow meter, a weir, or other suitable device for measuring the water to which the applicant is entitled;

That the type and plans of the measuring device be approved by the watermaster before the beginning of construction work and that the weir or measuring device be installed under the general supervision of said watermaster.

It is FURTHER ORDERED that the construction work shall be completed and the change in point of diversion of water made and said water so transferred shall be applied to beneficial use on or before October 1, 1979.

It is FURTHER ORDERED that the certificate of water right heretofore issued to Dr. C. J. Moser, and recorded at page 41727, Volume 33, State Record of Water Right Certificates, is canceled, and in lieu thereof a new certificate be issued covering the balance of the right NOT involved in this proceeding, and upon proof satisfactory to the Water Resources Director of completion of works and beneficial use of water to the extent intended under the provisions of this order, a confirming certificate of water right shall be issued to the applicant herein.
