

On November 5, 1974, an application was filed in the office of the Water Resources Director, in the name of Gene Bleak, later assigned to Elgin M. and Lucille R. Broome, for approval of a change in point of diversion from Rogue River, pursuant to the provisions of ORS 540.510 50 540.530.

The certificate recorded at page 38780, Volume 30, State Record of Water Right Certificates, in the name of Thomas and Velna Johnson, describes a right which includes the use of not to exceed 0.02 cubic foot per second from Rogue River for irrigation of a certain 1.4 acres in SE<sup>1</sup>/<sub>4</sub> NE<sup>1</sup>/<sub>4</sub> of Section 21, Township 34 South, Range 1 West, W.M., with a date of priority of December 15, 1933.

The authorized point of diversion for the said right is located 1750 feet North and 780 feet East from the Southwest Corner of Section 15, being within the  $NW_4^1$   $SW_4^1$  of Section 15, Township 34 South, Range 1 West, W.M.

It is FURTHER ORDERED that the certificate of water right heretofore issued to Thomas J. and Velna Johnson and recorded at page 38780, Volume 30, State Record of Water Right Certificates, is canceled, and in lieu thereof a new certificate be issued covering the balance of the right NOT involved in this proceeding, and upon proof satisfactory to the Water Resources Director of completion of works and beneficial use of water to the extent intended under the provisions of this order, a confirming certificate of water right shall be issued to the applicant herein.


