

On February 8, 1977, an application was filed in the office of the Water Resources Director by Stephen L. Van Iersel for a change in point of diversion under an existing water right of record, pursuant to the provisions of ORS 540.510 to 540.530.

The certificate recorded at page 43772, Volume 35, State Record of Water Right Certificates, in the Mame of C.O. and Albert Bigelow, describes a right which includes the use of not to exceed 0.26 cubic foot per second from West Fork Williams Creek for irrigation of 15.38 acres in NE% NW% of Section 8, Township 39 South, Range 5 West, W.M., with a date of priority of 1880.

Water for the said right is diverted, through the Hoxie Ditch, from a point located 1150 feet South and 1320 feet East from the Northwest corner of Section 8, being within the NE's NW's of said Section 8.

The applicant herein, owner of the lands above described, proposes to change the point of diversion therefrom, without loss of priority, to a point located 640 feet South and 2120 feet East from the Northwest corner of Section 8, being within the said NE% NW% of Section 8.

Mr. Robert B. Steimer, Watermaster, has filed a statement to the effect that the proposed change in point of diversion may be made without injury to existing rights.

No objections having been filed and it appearing that the proposed change in point of diversion may be made without injury to existing rights, the application should be approved.

That the diversion works shall include an in line flow meter, a weir or other suitable device for measuring the water to which the applicant is entitled;

That the type and plans of the measuring device be approved by the watermaster before the beginning of construction work and that the weir or measuring device be installed under the general supervision of said watermaster.

It is FURTHER ORDERED that the construction work shall be completed and the change in point of diversion made on or before October 1, 1979.

ORDER

On May 12, 1978, William J. and Judith Santos submitted an affidavit that they are the owners of a certain water right and the lands to which the water right is appurtenant; that they have abandoned any and all interest in and to said water right and request the same be canceled.

The water right in question was allowed by Decree of Circuit Court for Jackson County, entered April 26, 1919, in the Matter of the Determination of the Relative Rights to the Use of the Waters of West Fork Williams Creek, tabulated at page 27, Volume 4, Order Record of the Water Resources Department, in the names of C. O. and Albert Bigelow, and is described by the certificate recorded at page 43772, Volume 35, State Record of Water Right Certificates, and is for the use of not to exceed 0.16 cubic foot per second of water from West Fork Williams Creek, with a date of priority of 1880, for the irrigation of 10.0 acres in SW4 SE4 of Section 5, Township 39 South, Range 5 West, W.M.

NOW, THEREFORE, it hereby is ORDERED that the said water right, being a portion of the right described by the certificate recorded at page 43772, Volume 35, State Record of Water Right Certificates, is canceled.

The orders of the Water Resources Director entered July 25, 1977 and January 17, 1978, approving transfer applications No. 3518 and 3724, provided for the cancellation of said certificate and issuance of a new certificate covering the balance of the right NOT involved in the transfer proceedings, which balance of the water right is canceled herein; therefore,
