

FINDINGS OF FACTS

- 1. On August 16, 2005, the Department received an affidavit from Duane C. Smith and M. Teresa Smith, 11771 NW OAK Ridge Rd., PO Box 147, Yamhill, Oregon 97148, stating that they are the owner of lands and the water right appurtenant as evidenced by Certificate 49300, State Record of Water Right Certificates. The affidavit further states they have obtained a different source of water for primary irrigation of these lands and requests the water right be diminished from a right for primary irrigation to a right for supplemental irrigation of the lands.
- 2. The water right to be diminished is a portion of the right described by Certificate 49300, State Record of Water Right Certificates. The water right allows the use of not to exceed 0.41 cubic foot per second of water from North Yamhill River, tributary to the Yamhill River, for irrigation of 32.6 acres. The priority date is May 14, 1965. The point of diversion is located in SE¼ NW¼, As projected within Norris DLC 81, Section 6, Township 3 South, Range 4 West, W. M...
- 3. The affidavit requests the portion of Certificate 49300 appurtenant to the following lands be diminished from primary irrigation to supplemental irrigation:

- Certificate 49300 is canceled;

The portion of the water right for irrigation of 1.70 acres as described by Certificate 49300 is diminished from a right for primary irrigation to a right for supplemental irrigation; and the Department shall issue a new and superseding certificate, to confirm the diminution of the right described herein and to describe the unaffected portion of the right.

On May 2, 1977, an application was filed in the office of the Water Resources Director by Carl A. Corey for a change in point of diversion under an existing water right of record, pursuant to the provisions of ORS 540.510 to 540.530.

The certificate recorded at Page 42146, Volume 34, State Record of Water Right Certificates, in the name of Carl A. Corey describes a right for the use of not to exceed 0.74 cubic foot per second from North Yamhill River for irrigation of 10.4 acres in NE¹/₄ NW¹/₄, 25.3 acres in NW¹/₄ NW¹/₄, 12.8 acres in SW¹/₄ NW¹/₄ and 6.6 acres in SE¹/₄ NW¹/₄ of Section 6, Township 3 South, Range 4 West, W.M.; 3.9 acres in NE¹/₄ NE¹/₄ and 0.2 acre in SE¹/₄ NE¹/₄ of Section 1, Township 3 South, Range 5 West, W.M., with a date of priority of May 14, 1965.

That the type and plans of the measuring device be approved by the watermaster before the beginning of construction work and that the weir or measuring device be installed under the general supervision of said watermaster.

It is FURTHER ORDERED that the construction work shall be completed and the change in point of diversion of water made on or before October 1, 1979.

It is FURTHER ORDERED that the certificate of water right heretofore issued to Carl A.
