






LOCATED IN SECTION 33, TOWNSHIP 17 SOUTH, RANGE 13 EAST

ORDER APPROVING  
TRANSFER NO. 3308

On August 25, 1975, Cody H. and Donna M. Spahn filed an application in the office of the Water Resources Director for the approval of changes in place of use of water from Deschutes River, pursuant to the provisions of ORS 540.510 to 540.530.

By Decree of the Circuit Court for Deschutes County, Oregon, entered September 30, 1958, In the Matter of the Determination of the Relative Rights to the Use of the Deschutes River and its Tributaries, a water right was established in the name of Central Oregon Irrigation District for the use of the waters of Deschutes River for the irrigation of, among other lands, 7.3 acres in NW $\frac{1}{4}$  NW $\frac{1}{4}$ , 5.7 acres in NW $\frac{1}{4}$  SW $\frac{1}{4}$  and 10.1 acres in SW $\frac{1}{4}$  SW $\frac{1}{4}$ , Section 33, Township 17 South, Range 13 East, W.M., being tabulated in the name of John McLaughlin, with dates of priority of October 31, 1900, and December, 2, 1907, as evidenced by certificate of water right recorded at Page 29052, Volume 21, State Record of Water Right Certificates. These lands also have a supplemental right under permit No. 23256 to the use of the water stored in Crane Prairie Reservoir with a date of priority of February 28, 1913. These lands are irrigated by means of the Central Oregon Canal.

The applicants herein, owners of the lands above described, propose to transfer the water right therefrom, without loss of priority, to a certain 5.3 acres in NW $\frac{1}{4}$  NW $\frac{1}{4}$ , 0.5 acre in SW $\frac{1}{4}$  NW $\frac{1}{4}$ , 2.2 acres in NW $\frac{1}{4}$  SW $\frac{1}{4}$ , 5.1 acres in SW $\frac{1}{4}$  SW $\frac{1}{4}$  and 10.0 acres in SE $\frac{1}{4}$  SW $\frac{1}{4}$ , Section 33, Township 17 South, Range 13 East, W.M.

The lands involved herein are within the boundaries of the Central Oregon Irrigation District and the Board of Directors of said District approved the proposed change in place of use of water at a regular meeting held April 2, 1975.

Certain portions of the lands involved herein from which the water rights are being severed are under contracts of sale and the contract purchasers have all submitted statements in approval of the proposed changes in place of use.

No objection having been filed and it appearing that the proposed changes in place of use of water may be made without injury to existing rights, the application should be approved.


NOW, THEREFORE, it hereby is ORDERED that the requested changes in place of use described herein, without loss of priority, are approved.

It is FURTHER ORDERED that said water so transferred shall be applied to beneficial use on or before October 1, 1976.

It is FURTHER ORDERED that upon receipt of proof satisfactory to the Water Resources Director of complete application of water to beneficial use on the lands to which the water is transferred hereby, a certificate of water right will be issued to the Central Oregon Irrigation District confirming this and prior changes within the District.




