

ORDER APPROVING TRANSFER NO. 3959

On May 22, 1978, an application was filed in the office of the Water Resources Director by Norman Butler for approval of changes in points of diversion from Spring Creek, pursuant to the provisions of ORS 540.510 to 540.530.

The certificate recorded at page 4537, Volume 5, State Record of Water Right Certificates, in the name of A. F. Waltz, describes a right which includes the use of water from Spring Creek for irrigation of 17.5 acres with a priority date of 1866 and 5.0 acres with a priority date of 1880 in the SW4 SE4 of Section 28, Township 8 South, Range 39 East, W.M.

Water for the said right with the priority date of 1866 is diverted, through the A.F. Waltz No. 3 Ditch, from a point located 45 feet South and 2110 feet West from the Northeast Corner of Section 33, being within the NW% NE% of Section 33, Township 8 South, Range 39 East, W.M.

Water for the said right with the priority date of 1880 is diverted, through the A.F. Waltz No. 4 Ditch, from a point located 75 feet North and 2590 feet West from the Northeast Corner of Section 33, being within the SW% SE% of Section 28, Township 8 South, Range 39 East, W.M.

The applicant herein, owner of the lands above described, proposes to change the points of diversion therefrom and, without loss of priority, to hereafter divert water at a point located 2720 feet West from the Northeast Corner of Section 33, being within the NE4 NW4 of Section 33, Township 8 South, Range 39 East, W.M.

Mr. V. Kent Searles, Watermaster, has filed a statement to the effect that the proposed change in points of diversion may be made without injury to existing rights.

No objections having been filed and it appearing that the proposed change in points of diversion may be made without injury to existing rights, the application should be approved.

NOW, THEREFORE, it hereby is ORDERED that the requested change in points of diversion, as described herein, without loss of priority, is approved.

It is FURTHER ORDERED that the quantity of water diverted at the new point of diversion shall not exceed the quantity of water available at the old points of diversion under the subject right.

It is FURTHER ORDERED that the following provisions shall be carried out prior to the diverting of water at the new point of diversion as herein confirmed:

That the diversion works shall include an in line flow meter, a weir, or other suitable device for measuring the water to which the applicant is entitled;

That the type and plans of the measuring device be approved by the watermaster before the beginning of construction work and that the weir or measuring device be installed under the general supervision of said watermaster.

It is FURTHER ORDERED that the construction work shall be completed and the change in point of diversion of water made on or before October 1, 1980.

It is FURTHER ORDERED that the certificate of water right heretofore issued to A. F. Waltz and recorded at page 4537, Volume 5, State Record of Water Right Certificates, is canceled; and in lieu thereof a new certificate be issued covering the balance of the right NOT involved in this proceeding; and upon proof satisfactory to the Water Resources Director of completion of works and beneficial use of water to the extent intended under the provisions of this order, a confirming certificate of water right shall be issued to the applicant herein.
