Authority

ORS 540.570 establishes the process in which a district may submit a request to temporarily transfer a water right within district boundaries. OAR Chapter 690, Division 385 implements the statutes and provides the Department's procedures and criteria for evaluating district transfer applications.

Findings of Fact

1. On March 19, 2007, Westland Irrigation District filed a district transfer application to temporarily change the place of use under Certificates 76715 and 79439. The Department assigned the application number T-10346.
2. Notice of the application for transfer was published on April 3, 2007, pursuant to ORS 540.570 and OAR 690-385-4400. No comments were filed in response to the notice.
3. Westland Irrigation District specified water use under existing 16.2 acres of Certificate 79893 will become supplemental irrigation for the incoming District right, Certificate 76715, during the course of the 2007 Irrigation Season, and is fully described in Finding of Fact #7.
4. The portion of the first right to be transferred are as follows:
Certificate: 76715, issued in the name of Westland Irrigation District
Use: Irrigation (IR) of 16.2 acres
Priority Date: March 14, 1903
Rate & Duty: ONE-EIGHTIETH of one cubic foot per second (or its equivalent) from MARCH 1 to NOVEMBER 1, and subject to the limitations of Paragraph 32 of the Umatilla River Decree for each acre irrigated during the irrigation season of each year.

This is a final order in other than contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60 day time period specified by ORS 183.484(2). Pursuant to ORS 536.075 and OAR 137-004-0080 you may either petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

6. On March 19, 2007, Stacey Wells, authorized representative for Westland Irrigation District, on behalf of the landowner, submitted an "Affidavit of Non-Use During Temporary Transfer" indicating there were three water rights (Certificate 38388, 76750 and 76746) for supplemental irrigation appurtenant to certain "FROM" lands. The affidavit indicated that these rights, described in the following tables, would not be exercised during the 2007 irrigation season.

Diminishment of a certain Water Right during the 2007 Irrigation Season

- On April 19, 2007, Stacey Wells, authorized representative for Westland Irrigation District, stated that 16.2 acres, evidenced by Certificate 79893, are appurtenant to certain "TO" lands and requested this appurtenant water right be diminished from primary irrigation to supplemental irrigation for the duration of the temporary transfer. This land is described in the following table:

- The district temporary transfer application satisfies the criteria of OAR 690-385-4000, contains the information required under OAR 690-385-2000, and includes maps meeting the requirements of OAR 690-385-2200.
- The water rights are subject to transfer as defined in OAR 690-385-0100(17).
- The proposed change in place of use would not result in enlargement of the rights.
- The proposed changes in place of use would not result in injury to other rights.

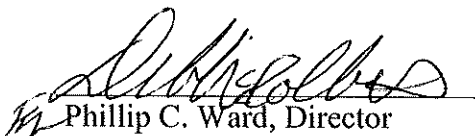
Conclusions of Law

- The proposed change in place of use in Transfer Application T-10346 satisfies the requirements of ORS 540.574(3) and 540.570.
- The portions of the rights described in Findings of Fact #6 will not be used during the 2007 irrigation season.
- The portions of the right described in Findings of Fact #7 will be diminished to supplemental irrigation during the 2007 irrigation season.

Now, therefore, it is ORDERED:

1. The proposed changes to the water rights evidenced by Certificates 76715, 79439 and 79893 are approved.
2. The temporary transfer is effective for the 2007 irrigation season.
3. The right to the use of the water is restricted to beneficial use at the place of use described and is subject to all other conditions and limitations contained in Certificates 76715, 79439, 79893 and any related decree.
4. Pursuant to OAR 690-385-3130, the use of water for supplemental irrigation at the proposed place of use under Certificate 79893, as described in Findings of Fact #6, is restricted to the total rate and duty described by Certificate 76715, and may be used only to make up a deficiency of supply.
5. The use of water for supplemental irrigation under portions of Certificates 38388, 76746 and 76750, as described in Findings of Fact #6, will not be used during the 2007 irrigation season..
6. The use of water on the lands from which the water right is transferred and at the new temporary place of use during the same irrigation season or calendar year is prohibited and may subject the district and landowner to civil penalties.
7. The use of water under this temporary transfer may be conditioned or revoked at any time to the extent necessary to avoid injury if the Department finds the transfer causes injury to any existing water right.
8. At the end of the 2007 irrigation season all uses of water under this temporary transfer revert automatically to the terms and conditions of the original water right permit, certificate, or adjudication as evidenced by a court decree.

The holder of a water right may apply to permanently change an existing water use subject to transfer. A transfer application may involve any of the following changes: Point of diversion or appropriation (POD; POA); Additional point of diversion or appropriation (APOD; APOA); Historic POD (HIST); Place of use (POU); Character of use (USE); Instream (ISWR); Substitution (SUB); or Exchange (EXCH).

The holder of a water right subject to transfer may request to temporarily change the place of use of the water for up to 5 years and, if necessary to convey the water, to temporarily change the point of diversion or appropriation.

The holder of a water right permit may apply to change a point of diversion (POD) or appropriation (POA) or to change the place of use (POU).

Any person who provides comments within the comment period will receive a copy of the Department's preliminary determination of whether the application should be approved or rejected after the Department has completed a review of the application and will be provided an opportunity to protest the application and preliminary determination at that time. The Director may presume that the transfer would be allowed by, and compatible with comprehensive plans unless an affected local government informs the Director otherwise within 30 days of this notice. confirms the right to use the waters of the UMATILLA RIVER, a tributary of the COLUMBIA RIVER, for IRRIGATION, AND STOCK WATER OF 2649.6 ACRES.

This right was confirmed by decree of the Circuit Court of the State of Oregon for UMATILLA COUNTY. The decree is of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 3, at Pages 246-247 and Volume 15, at Pages 437-439, and 441. The date of priority is MARCH 14, 1903.

The use is limited to 33.1 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the Umatilla River.

The point of diversion is located as follows:

NORTH 76 DEGREES 45 MINUTES 56 SECONDS EAST 2913.19 FEET FROM THE WEST 1/4 CORNER OF SECTION 21, BEING WITHIN SW 1/4 NE 1/4 OF SECTION 21, TOWNSHIP 3 NORTH, RANGE 29 EAST, W.M. UMATILLA COUNTY.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) from MARCH 1 to NOVEMBER 1 and subject to the limitations of paragraph 32 of the Umatilla River Decree for each acre irrigated during the irrigation season of each year.

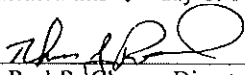

confirms the right to use the waters of the McKAY RESERVOIR, constructed under reservoir Permit R-564, a tributary of the McKAY CREEK, for SUPPLEMENTAL IRRIGATION OF 12,832.6 acres of land within the Westland Irrigation District.

This right was perfected under Permit 7400. The date of priority is JULY 1, 1924. This right, together with rights issued for lands within Stanfield Irrigation District and all private contracts with the U.S.B.R. for water stored in McKay Reservoir, is limited to 73,250 ACRE FEET of stored water, measured at the point of diversion from the source.

The point of diversion is located as follows:

McKay Dam - NW¼ SE¼, SECTION 34, TOWNSHIP 2 NORTH, RANGE 32 EAST, W.M.;
Water is run down the natural channels of McKay Creek and the Umatilla River and is re-diverted at Westland Irrigation District Canal: SW ¼ NE¼ OF SECTION 21, TOWNSHIP 3 NORTH, RANGE 29 EAST, W.M.; NORTH 76 DEGREES 45 MINUTES 56 SECONDS EAST 2913.19 FEET FROM THE WEST 1/4 CORNER OF SECTION 21.

The amount of water used for irrigation together with the amount secured under any other right existing for the same lands, is limited to a diversion of one eightieth of one cubic foot per second (or its equivalent), provided further that the right allowed herein for supplemental irrigation shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed therein.

The water user shall comply with the terms and conditions of a valid Water Contract between the Bureau of Reclamation and the water user. The Watermaster shall distribute water to the designated points of diversion according to ORS 540.410 and valid water service contracts as may be amended from time to time.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

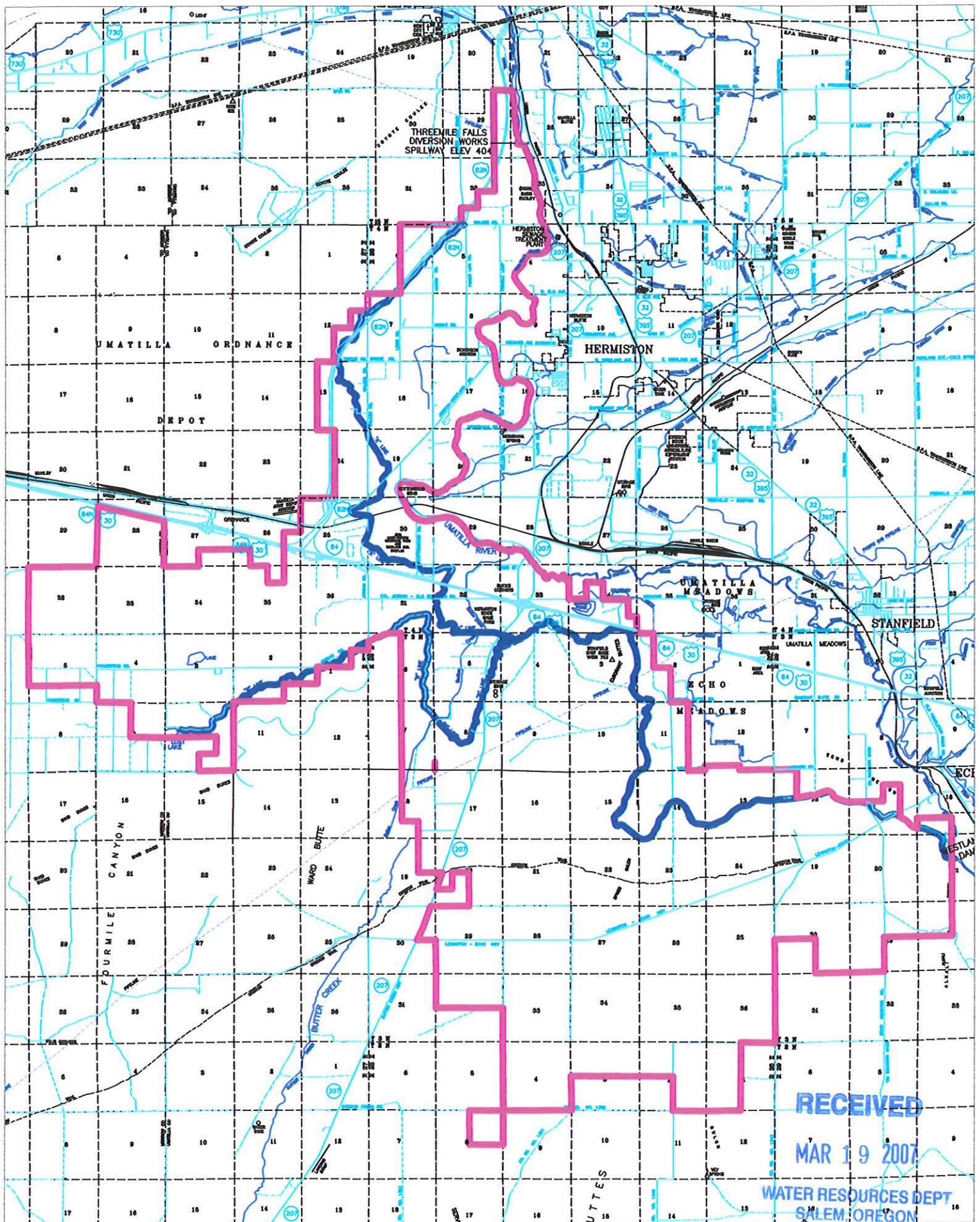
