**Authority**

ORS 540.505 to 540.580 establishes the process in which a water right holder may submit a request to transfer the point of diversion, place of use, or character of use authorized under an existing water right. OAR Chapter 690, Division 380 implements the statutes and provides the Department's procedures and criteria for evaluating transfer applications.

**Findings of Fact**

1. On September 26, 2003, William and Lila Roth filed a transfer application to change the point of diversion under Certificate 76999. The Department assigned the application number T-9569.
2. On December 22, 2006, the applicants submitted a revised application map clarifying the acres not affected by this transfer.

3. The portion of the first right to be transferred is as follows:

**Certificate:** 76999 in the name of GEORGE C. BAILEY (perfected under Permit S-8700)  
**Use:** IRRIGATION of 0.35 ACRE  
**Priority Date:** SEPTEMBER 24, 1928  
**Rate:** 0.004 CUBIC FOOT PER SECOND  
**Limit/Duty:** ONE-EIGHTIETH cfs per acre  
**Source:** NORTH UMPQUA RIVER, tributary to UMPQUA RIVER

**Authorized Point of Diversion:**

Pursuant to OAR 690-380-4030, any person may file a protest or standing statement within 30 days after the last date of publication of notice of this preliminary determination.

**Authorized Place of Use:**

**IRRIGATION**

4. The Department received additional information that more specifically describes the authorized point of diversion as being located as follows:

5. Transfer Application T-9569 proposes to move the authorized point of diversion approximately 520 feet downstream from the authorized point of diversion to:

6. Transfer applications T-9548, T-9561, T-9563, T-9569 and T-9580 all propose changes to the same water right, evidenced by Certificate 76999. T-9548, T-9561, T-9563 and T-9569 are being processed concurrently. T-9580 will be processed at a later time.
7. Notice of the application for transfer was published on October 14, 2003, pursuant to ORS 540.520 and OAR 690-380-4000. No comments were filed in response to the notice.
8. Oregon Department of Fish and Wildlife did request inclusion of a condition requiring installation of proper fish screens. Additionally, ODFW commented that there are five transfer applications all proposing to modify Certificate 76999 and documented concerns that the total combined system capacity for all five transfers totals more than the quantity of water allowed under the originating water right.
9. Water Resources Department has concluded that while the capacity of the systems totals more than the quantity of water authorized under the originating water right (Certificate 76999), each final order issued for the transfer applications (T-9548, T-9561, T-9563, T-9569 and T-9580) will be limited to that percentage of the total rate that is proportionate to the place of use involved in each transfer, so as not to exceed the quantity authorized under the original water right.
10. Water has been used within the last five years according to the terms and conditions of the right, and no evidence is available that would demonstrate that the right are subject to forfeiture under ORS 540.610.

11. A pump, pipeline, and sprinkler system sufficient to use the full amount of water allowed under the existing right are present.
12. The proposed change would not result in enlargement of the right.
13. The proposed change would not result in injury to other water rights.

#### **Determination and Proposed Action**

The proposed change in point of diversion in Transfer Application T-9569 appears to be consistent with the requirements of ORS 540.505 to 540.580, and OAR 690-380-5000, and will be approved provided that protests are not filed pursuant to OAR 690-380-4030.

*If application T-9569 is approved, the final order will include the following:*

1. *The change in point of diversion proposed in application T-9569 is approved.*
2. *Water right certificate 76999 is cancelled. A new certificate will be issued describing the portion of the right not involved in Transfer Applications T-9548, T-9561, T-9563 and T-9569.*
3. *The right to the use of the water is restricted to beneficial use at the place of use described, and is subject to all other conditions and limitations contained in Certificate 76999 and any related decree.*
4. *The approved changes shall be completed and full beneficial use of the water shall be made on or before **October 1, 2008**. A Claim of Beneficial Use prepared by a Certified Water Rights Examiner shall be submitted by the applicant to the Department within one year after the deadline for completion of the changes and full beneficial use of the water.*
5. *The quantity of water diverted at the new point of diversion shall not exceed the quantity of water lawfully available at the original point of diversion.*
6. *When required by the Department, the water user shall install and maintain a headgate, an in-line flow meter, weir, or other suitable device for measuring and recording the quantity of water diverted. The type and plans of the headgate and measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.*
7. *The water user shall install and maintain a fish screen or fish by-pass device, as appropriate, at the new point of diversion. The type and plans of the screen or by-pass device must be approved by the Oregon Department of Fish and Wildlife prior to beginning of construction, and shall be installed under the supervision of the Department of Fish and Wildlife.*
8. *When satisfactory proof of the completed change is received, a new certificate confirming the right transferred will be issued.*
