*Example for Line 5a calculation to transfer 45.0 acres of Primary Certificate 12345 (total 1.25 cfs for 100 acres) and 45.0 acres of Supplemental Certificate 87654 (1/80 cfs per acre) on the same land:

- For irrigation calculate cfs for each water right involved as follows:
 - Divide total authorized cfs by total acres in the water right (for C12345, $1.25 \text{ cfs} \div 100 \text{ ac}$); then multiply by the number of acres to be transferred to get the transfer cfs ($45 \text{ ac} \times 0.0125 \text{ cfs/ac} = 0.56 \text{ cfs}$).
 - If the water right certificate does not list total cfs, but identifies the allowable use as 1/40 or 1/80 of a cfs per acre; multiply number of acres proposed for change by either 0.025 (1/40) or 0.0125 (1/80). (For C87654, $45.0 \text{ ac} \times 0.0125 \text{ cfs/ac} = 0.56 \text{ cfs}$)

Certificate 51821 authorizes a rate of 2.99 cfs from this well. Well 12 is located on the south side of Hwy 730 in the NW corner of the SENE of Section 34. Certificate 51821 authorizes the irrigation of 239.3 acres. Only 13.1 acres are involved in this transfer. There is a buried pipe network that extends from the well to the pivot points of three circular irrigation machines on the south side of the highway. There is a buried pipeline that crosses beneath the highway near the center of Section 34 and then extends to the north being part of a larger distribution system. A branch pipeline connects to the pipeline extending to the north and extends southwesterly and serves two parcels of land involved in this transfer.**




