



Description of Water Delivery System

Describe the current water delivery system or the system that was in place at some time within the last five years. Bear Creek arises from multiple Springs located approximately 1,000 feet west of POD 1 and flows east through a small channel. At POD 1 the water can flood irrigate the area immediately east of POD1, the water can also flow east through a neighboring parcel to which no water rights of Certificate 38405 are appurtenant. At POD 2 the water can flood irrigate the area immediately south and east of POD 2 or flow into an 8" buried mainline that conveys water adjacent to the Bear Creek channel also allows flood irrigation to the east.

The water user proposes to add a point of diversion (POD 3) approximately 220' SE of POD 1 where the waters of Bear Creek will flow into an 8" buried mainline to be routed ENE then S around the neighboring property. The mainline will then then discharge into the Bear Creek channel immediately west of POD 2.




