
Pursuant to ORS 540.570, North Marion Irrigation District filed a request to move the place of use of certain water rights within the district for the 1996 irrigation season. The changes requested are enumerated on the attached sheet. Notice of the request was published in summary form by the Water Resources Department on January 16, 1996. Public comments were accepted for 30 days following publication. No comments were received.

As described in OAR 690-21-070 (3), staff have reviewed the request to determine if the change would injure existing rights or result in enlargement of the subject rights. This review finds that no injury or enlargement will occur. Therefore, the request as enumerated on the attached sheet is approved for the 1996 irrigation season.

The right to use the subject rights on the "off" lands is suspended for the 1996 irrigation season.

Copies of the approved request and associated maps are on file at the Department office in Salem.
