




A valve at Well-1 allows for water to be either directed into pressure tanks for domestic use and lawn irrigation at the farmhouse or into the irrigation distribution system. When the valve is turned to the irrigation distribution system, water can be pumped to any point within the place of use of either Cert. 98829 or 98830. The well is connected to the various fields in the place of use via a buried line with multiple risers for the connection of surface laterals and sprinklers. Several dozen risers along the distribution system allow for the connection of lateral lines or big-gun sprinklers. Above-ground lines cross East Birch Creek in multiple locations to connect the buried distribution line. A system drain valve is located at the low point at the west end of the distribution system.




