 The City of Albany proposes to add the NW 1/4 NW 1/4 of Section 4, Township 11 South, Range 3 West, Willamette Meridian, to the authorized place of use under Certificate 83325. The transfer will allow municipal water service to this area as part of the City's municipal water system. The point of diversion, source, and character of use remain unchanged. The transfer supports municipal water supply to lands within the City of Albany service area.
