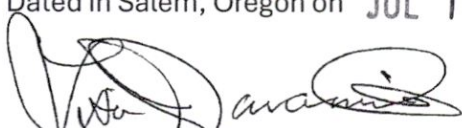
Findings of Fact

1. Transfer Application T-14507, in the name of Christopher James Ray and Anne Rebecca Ray, was filed on July 22, 2024.
2. On June 12, 2026, the Department issued a Proposed Final Order to approve Transfer Application T-14507.
3. On June 30, 2026, the Watermaster contacted the caseworker with new information regarding water right certificate 82615. The watermaster will be revising the Watermaster Review. To accommodate the updated review, the Proposed Final Order will be withdrawn.
4. Once the revised Watermaster Review is complete, the Department will issue a Revised Initial Review.
