The landowner seeks to add a point of diversion to increase the flexibility and efficiency of their irrigation system.

The landowner in conjunction with the Malheur Watershed Council and Warm Springs Irrigation District has made improvements to the site irrigation system drainage and is now using a pond to settle-out sediment before entering the Malheur River. Benefits include reducing the amount of suspended material in the river, prevent soil erosion, weed invasion, and prevent water loss due to infiltration and evapotranspiration.
