# Authority

ORS 537.705 and 540.505 to 540.580 establish the process in which a water right holder may submit a request to transfer the point of appropriation, place of use, or character of use authorized under an existing water right. OAR Chapter 690, Division 380 implements the statutes and provides the Department's procedures and criteria for evaluating transfer applications.

# Findings of Fact

- 1. On August 22, 2006, Ken and Maria Cade filed an application for additional points of appropriation and to change the place of use under Certificates 75658, 52873, and 81814. The Department assigned the application number T-10231.
- 2. On November 24, 2006, Certificate 75658 was superseded by Certificate 82639 as a result of a final order for T-10161.
- 3. The first right to be transferred is as follows:

- 12. Notice of the application for transfer was published on August 8, 2006, pursuant to ORS 540.520 and OAR 690-380-4000. No comments were filed in response to the notice.
- 13. Water has been used within the last five years according to the terms and conditions of the rights, and no evidence is available that would demonstrate that the rights are subject to forfeiture under ORS 540.610.
- 14. Pumps, pipelines, and sprinkler systems sufficient to use the full amount of water allowed under the existing rights are present.
- 15. The proposed changes would not result in enlargement of the rights.
- 16. The proposed changes would not result in injury to other water rights.

#### **Determination and Proposed Action**

The additional points of appropriation and change in places of use proposed in application T-10231 appear to be consistent with the requirements of ORS 537.705, 540.505 to 540.580, and OAR 690-380-5000, and will be approved provided that protests are not filed pursuant to OAR 690-380-4030.

If approved, the change and subsequent use of water shall be subject to the following conditions:

- 1. The right to use of the water is restricted to beneficial use at the place of use described, and is subject to all other conditions and limitations contained in Certificates 82639, 52873, and 81814, and any related decree.
- 2. Certificates 82639, 52873, and 81814 are cancelled. New certificates will be issued describing the portion of the right evidenced by Certificate 81814 not involved in this transfer.
- 3. Water shall be acquired from the same aquifer (water source) as the original points of appropriation.
- 4. The approved changes shall be completed and full beneficial use of the water shall be made on or before **October 1, 2008.** A Claim of Beneficial Use prepared by a Certified Water Rights Examiner shall be submitted by the applicant to the Department within one year after the deadline for completion of the changes and full beneficial use of the water.

- 5. The quantity of water diverted at the proposed additional points of appropriation, together with that diverted at the original points of appropriation, shall not exceed the quantity of water lawfully available at the original points of appropriation.
- 6. The former places of use of the transferred water shall no longer receive water as part of these rights.
- 7. Prior to diverting water at the new points of appropriation, the water user shall install and maintain in-line flow meters or other suitable devices for measuring and recording the quantity of water appropriated. The type and plans of the measuring devices must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.
- 8. When satisfactory proof of the completed changes is received, new certificates confirming the rights transferred will be issued.
