Briefly describe: Development of on-farm and pumping plant efficiencies over the past 5 years have/will result in savings of approximately 37% of the water needed per acre. 75% of water conserved will be relocated to areas within the farm not currently covered with water rights, with the balance of 25% resulting in instream rights in the Snake River, as per state rules.
