David and I appreciate the meeting with you, Debbie and Doug regarding the Whitehorse Ranch transfer. We needed to clarify several items to complete the information you needed. Mr. Herman decided to construct the reservoirs to maintain some dead storage for fish and wildlife. They will each have a minimum pool of about 25 acre feet. I will survey this in the next few weeks. This means the storage should be for multipurpose use and not just irrigation. I annotated and initialed the application form for multipurpose use.

Reservoir #1 should store 120.9 acre feet and #2 should store 124.5 acre feet. The reservoirs will be filled from the existing ditch #1. The ditch has been maintained around the east side of the reservoirs so both reservoirs get water from below the fish screen. Mr. Herman agreed to install headgates and weirs for each reservoir.

The reservoir dams were wrapped up along ditch #2 on the west side so the reservoirs are entirely off channel. This allows the ranch to use ditch #2 much easier than running it through the dams. The amended map I sent earlier shows this alignment. I believe this covers the issues we discussed. If you have any questions just call. Thank you for your time.
