

- 1.5 Validity of Rights. Lessor #1 attests (mark one) that:
  - x the water has been used over the past five years according to the terms and conditions of the owner's water right certificate or
  - $\Box$  that the water right is not subject to forfeiture under ORS 540.610.
- **1.6 Lease.** Lessor agrees to lease the water rights listed in 1.4 for instream use for the term of this Agreement through Lessee to Trustee, the Oregon Water Resources Department, pursuant to the provisions of ORS 537.348(2) and OAR 690-077-0077.
- 1.7 Suspension of original use. During the period of the lease, the owner agrees to suspend use of water allowed under the subject water rights and under any water right that is supplemental to the subject water rights.
- **1.8** Water use reporting. The trustee agrees to fulfill legal obligations related to water use reporting.

- **Public Use.** The public use served by the amount, timing and location of the instream use provided for under this lease is:
  - Provided by evidence contained in Exhibit E, such as a signed statement by Lessee, or other party, explaining how the lease would benefit recreation, scenic attraction, aquatic and fish life, wildlife habitat and ecological values, pollution abatement, navigation or other public uses.

Type of use: Water quality and other public benefits as described in Section 2.1 above.

Total volume: 626.4 acre feet

Rate: 3.295 cfs

Period of Use: March 1 – October 31.

Conditions to prevent injury, if any: The instream flow will be allocated on a daily basis, up to the rate, from July 1 to October 3, 2001, or until such time that the total duty for the irrigation season is met. (95 days expected at maximum rate.)

Location: POD to the Oregon/Washington border on the Snake River, a tributary to the Columbia River, in the Columbia River Basin.

Priority date: June 13, 1977

Type of use: Water quality and other public benefits as described in Section 2.1 above.

Total volume: 611.2 acre feet

Rate: 4.26 cfs

Period of Use: Mar. 1 – Oct. 31.

Conditions to prevent injury, if any: The instream flow will be allocated on a daily basis, up to the rate, from July 1 to September 10, 2001, or until such time that the total duty for the irrigation season is met. (72 days expected at maximum rate.)

- **2.3 Term of lease.** This Lease shall commence on March 1, 2001 (not before execution by the parties) and continue through October 31, 2001.
- **2.4** Compensation. The Lessor has agreed to lease subject water rights herein to BPA for cash and other consideration and for the benefit of the people of the state of Oregon.
- 2.5 Flow protection. The Trustee will regulate use of water from the source, subject to prior appropriation and the agency enforcement guidance, to assure the water is delivered to the point of diversion, and through the reach past junior downstream users, so long as flow is sufficient to meet the demand under priority date of the new instream use (see section 2.2). No party is required to continuously measure the flow of the waterway described in Section 2.2.

- **Watermaster review.** By signature below, the watermaster for the district where the subject water right is located verifies that:
- 3.1 Lessor is currently entitled to appropriate water under the water rights described in Section 1.4.

- 3.2 A suitable control is in place so that WRD staff may regulate use of water under the subject right to ensure water is not diverted or applied on lands to which subject right is attached.
- 3.3 Allocation of water to the new instream use described in Section 2.2 during the term of this lease is not reasonably expected to cause injury to other rights to use water from the same source.
