1.5 **Validity of Rights.** Lessor attests that the subject water rights are legally valid by having been beneficially used according to the terms of the rights within the last five years immediately preceding the 1996 irrigation year and, if the rights are for irrigation, on all lands indicated in *Exhibit D* that are under lessor's ownership.

- Lease. Lessor agrees to lease the water rights listed in 1.4 for instream use for the term of this Agreement through Lessee to Trustee, the Oregon Water Resources Department, pursuant to the provisions of ORS 537.348(2) and OAR 690-77-077.
- Suspension of original use. During the period of the lease, the owner agrees to suspend use of water allowed under the subject water rights and under any water right that is supplemental to the subject water rights.
- 1.8 **Water use reporting.** The Trustee agrees to fulfill legal obligations related to water use reporting.

2.1 **Public Use.** The public use served by the amount, timing and location of the instream use provided for under this lease is:

2.2 **Instream use created by lease.** The instream use to be created is described as follows:

Trout Creek, tributary to the Deschutes River

Location: From the upper P.O.D. described in 1.4 (near RM 40) to the mouth of Degner Canyon (near RM 25)

Priority dates: 1879, 1884, 1891, 1894, and 1895 Use: Instream (described in Section 2.1, above)

Total volume: A quantity of water limited to 1,135.5 acre feet during the irrigation season.

Rate: 4.73 cfs (Total) 1.73 cfs (1879) 1.17 cfs (1884) 0.41 cfs (1891) 0.11 cfs (1894) 1.31 cfs (1895)

Period of use: All year

Conditions to prevent or mitigate injury, if any: The rate of the water right has been adjusted as follows to meet seasonal duty restrictions:

The total rate of the instream water right is 4.73 cfs. The instream flow will be allocated on a daily average basis up to this rate from June 1 until September 30, or until such time that the total duty for the irrigation season is met.

2.3 **Term of lease.** This Lease shall commence on January 1, 1996 (not before execution by the parties) and continue through December 31, 1996.

- Compensation. Lessor has agreed to lease the water rights herein to the Oregon 2.4 Water Trust for cash and other considerations and for the benefit of the people of the state of Oregon.
- Flow protection. The Trustee will regulate use of water from the source, subject to 2.5 prior appropriation and the agency enforcement guidance, to assure the water is delivered to the point of diversion, and through the reach past junior downstream users, so long as flow is sufficient to meet the demand under priority date of the new instream use (see Section 2.2). No party is required to continuously measure the flow of the waterway described in Section 2.2.

Optional Provisions

- Additional monitoring. Lessee intends to manage and participate in the protection of 2.6 the instream use by: possibly collecting information for calculating stream discharge.
- 2.7 Modification or termination provisions. None

- Watermaster review. By signature below, the watermaster for the district where the 3 subject water right is located verifies that:
- 3.1 Lessor is currently entitled to appropriate water under the water rights described in Section 1.4.
- 3.2 A suitable control is in place so that WRD staff may regulate use of water under the subject right to ensure water is not diverted or applied on lands to which subject right is attached.
- 3.3 Allocation of water to the new instream use described in Section 2.2 during the term of this lease is not reasonably expected to cause injury to other rights to use water from the same source.
