- Reason(s) for amendment/modification(s): Port's periodic dredging operations requires the use of water for on-loading and off-loading activities on their dredge materials barge along either Hayden Island and the Rivergate Industrial District/Terminal 4 shorelines. The pumps for these activities are located on the Port Dredge barge and are considered portable pump stations. This amendment requests an additional Point of Diversion "area" to encompass the areas where the portable pump may be used and request a modification of the Place of Use under the Port's municipal use Permit S-51547 to encompass the water use areas associated with this activity. The Port is also changing one of the authorized Swan Island PODs to accurately reflect the POD location.
