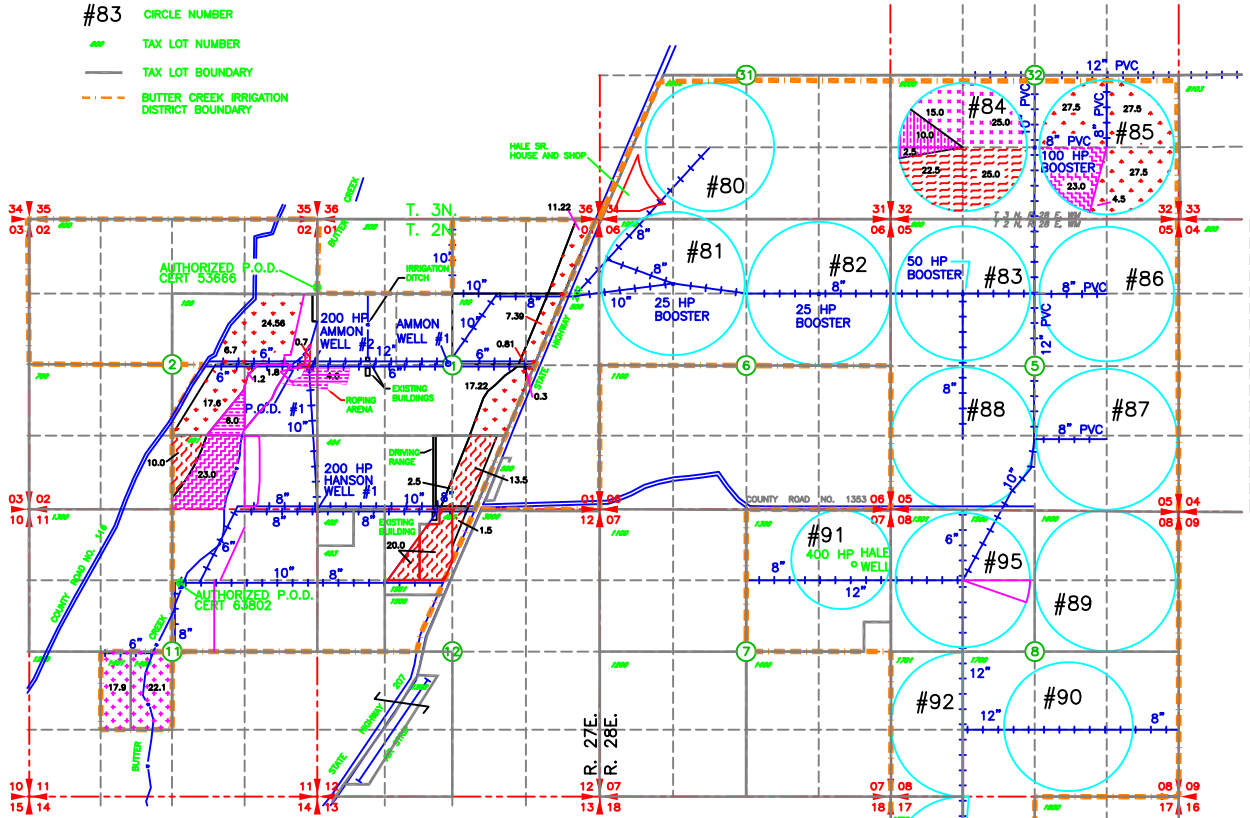


BUTTER CREEK IRRIGATION DISTRICT TEMPORARY TRANSFER 2009

- - - BUTTER CREEK IRRIGATION DISTRICT BOUNDARY

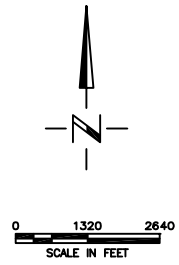
