Enclosed are copies of the District's Petitions For Permanent Transfer, and "FROM" and "TO" maps for each of the following District files:



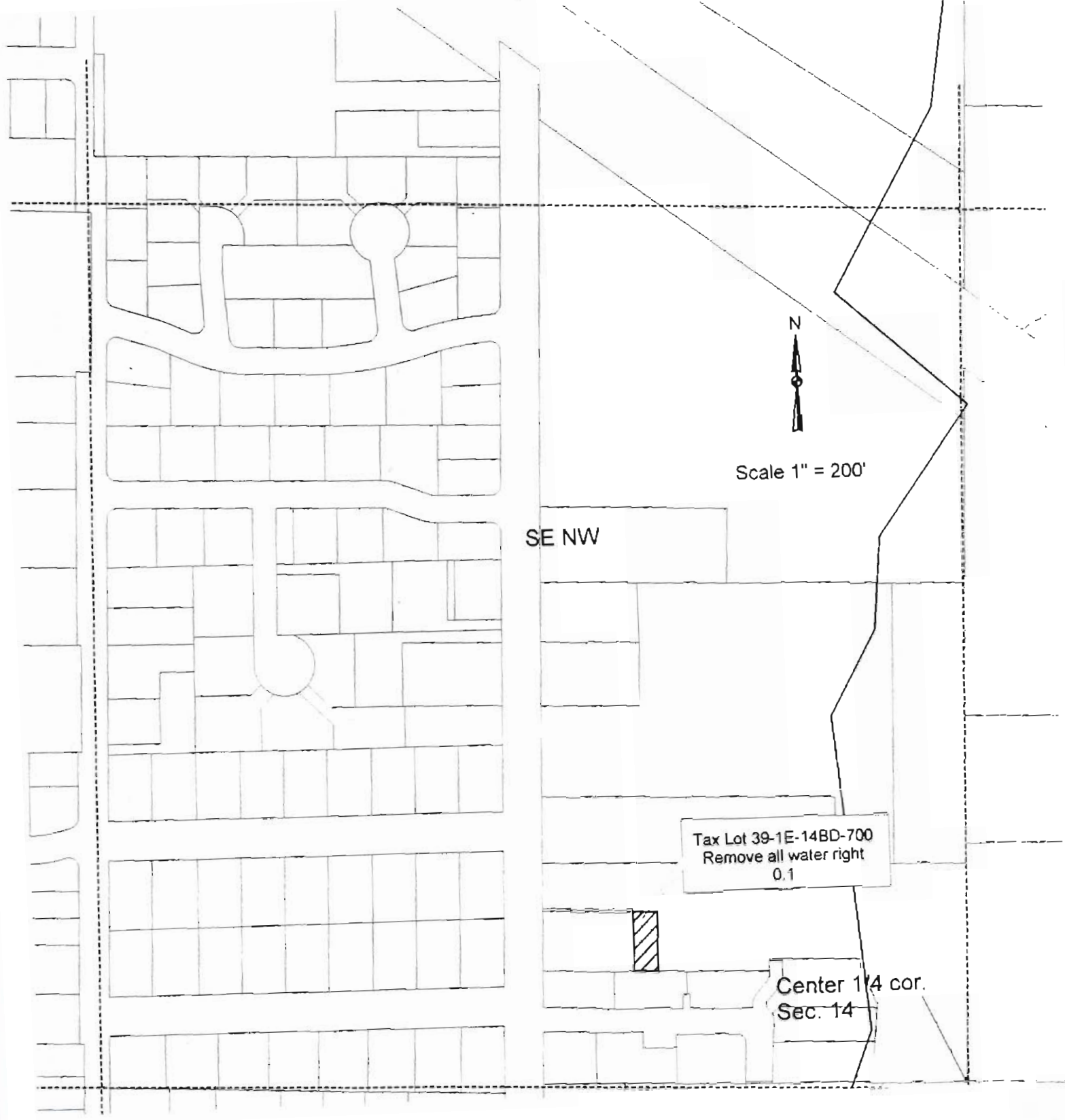

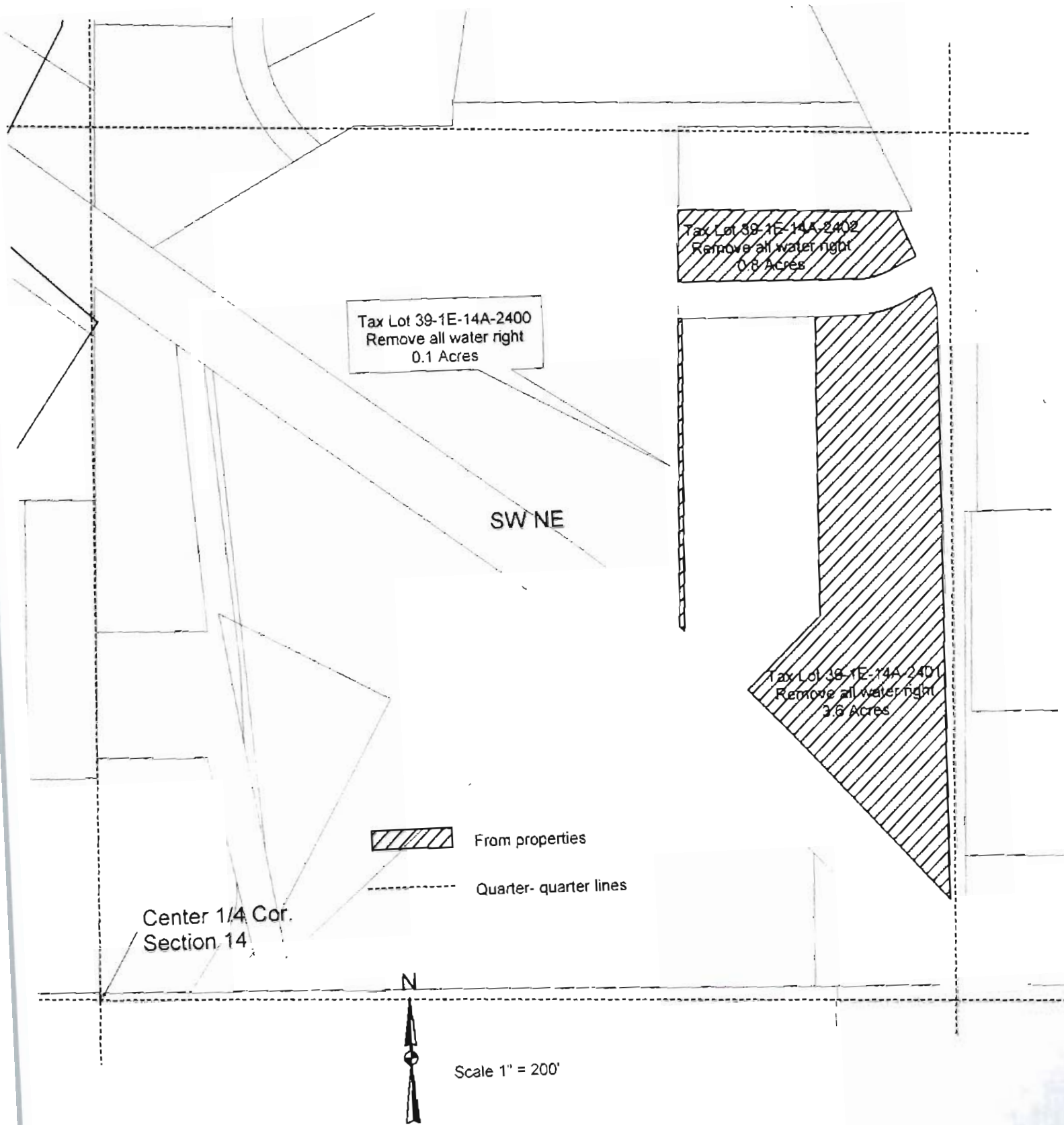

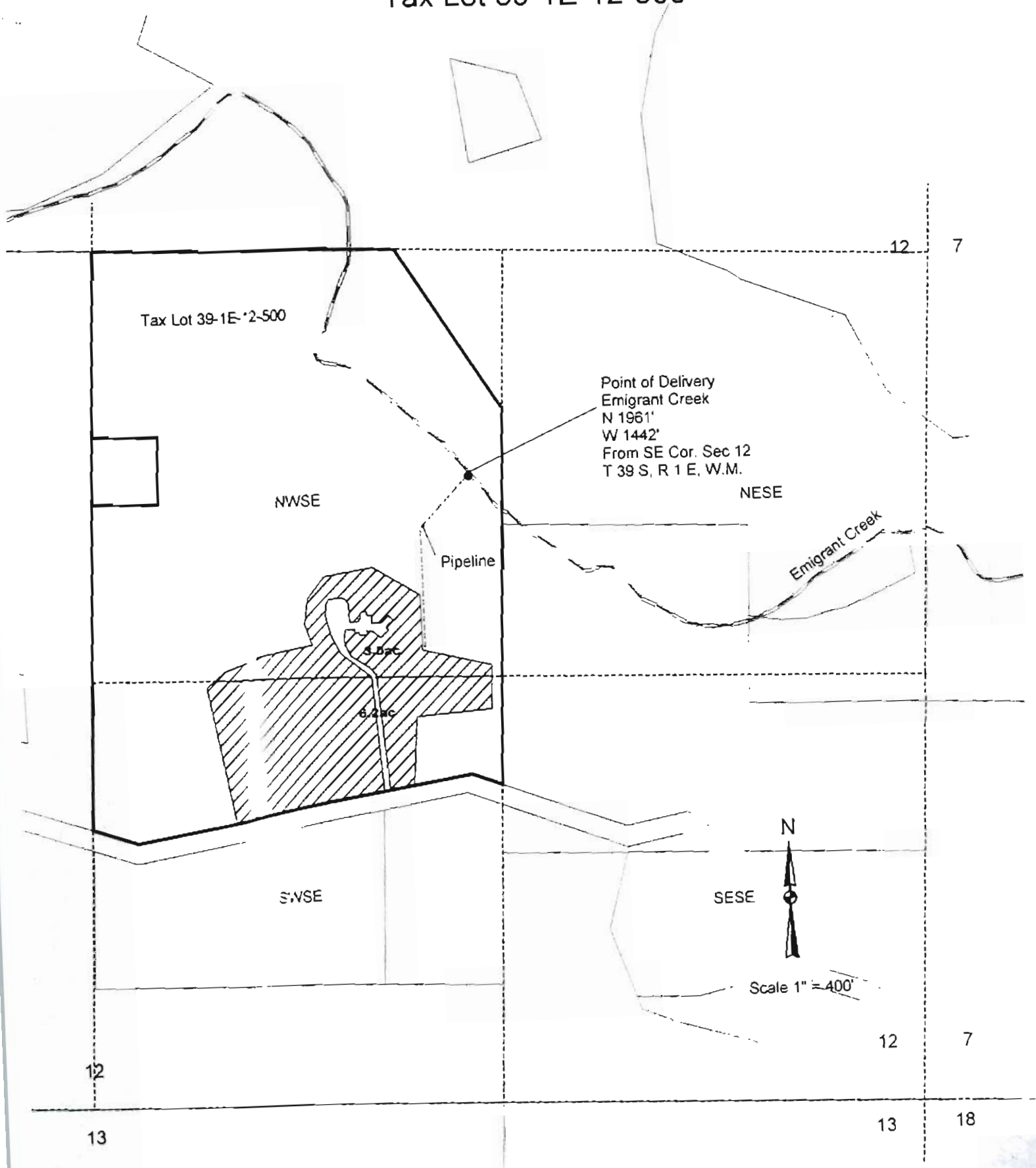

MAP OF SURVEY

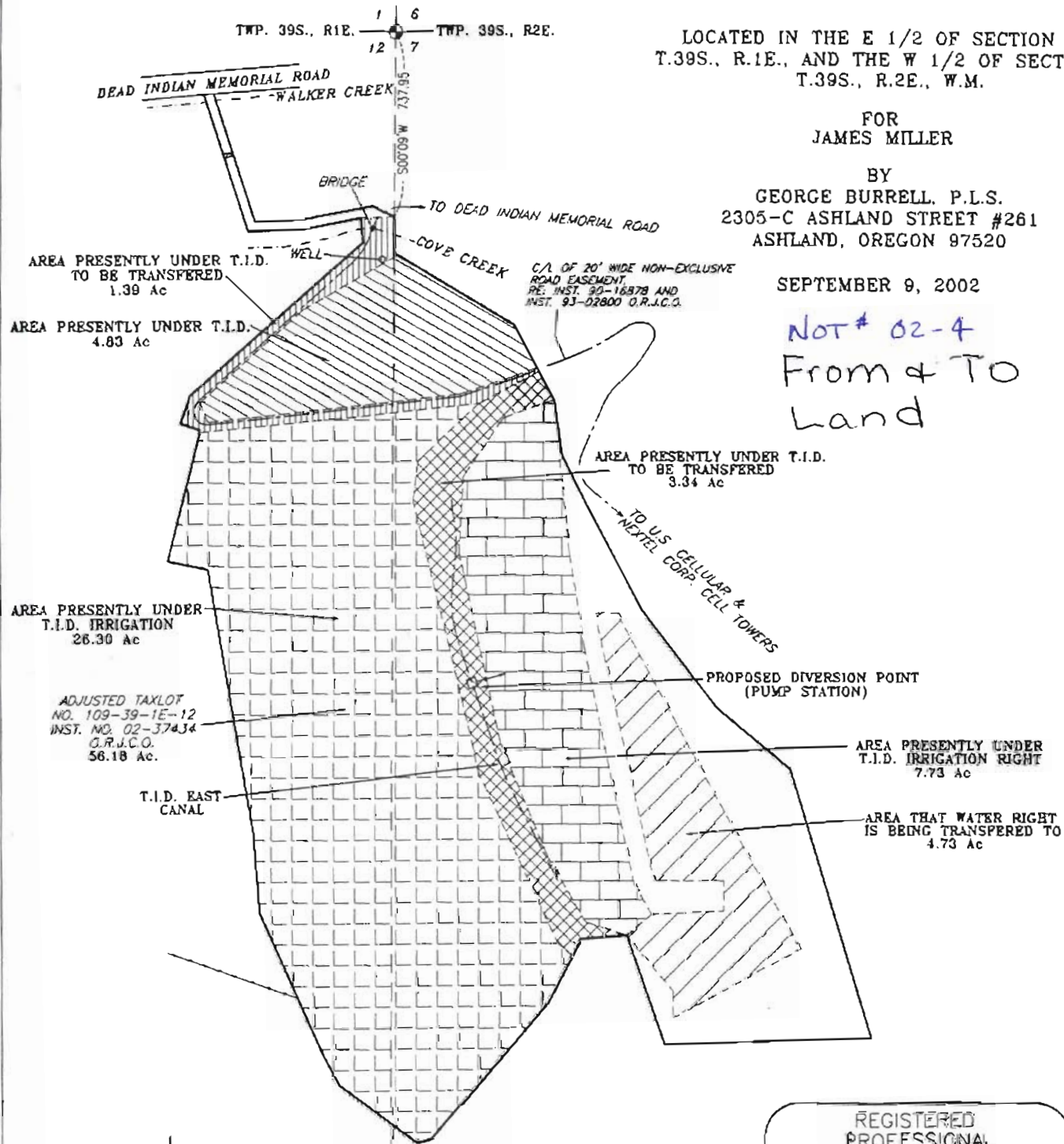

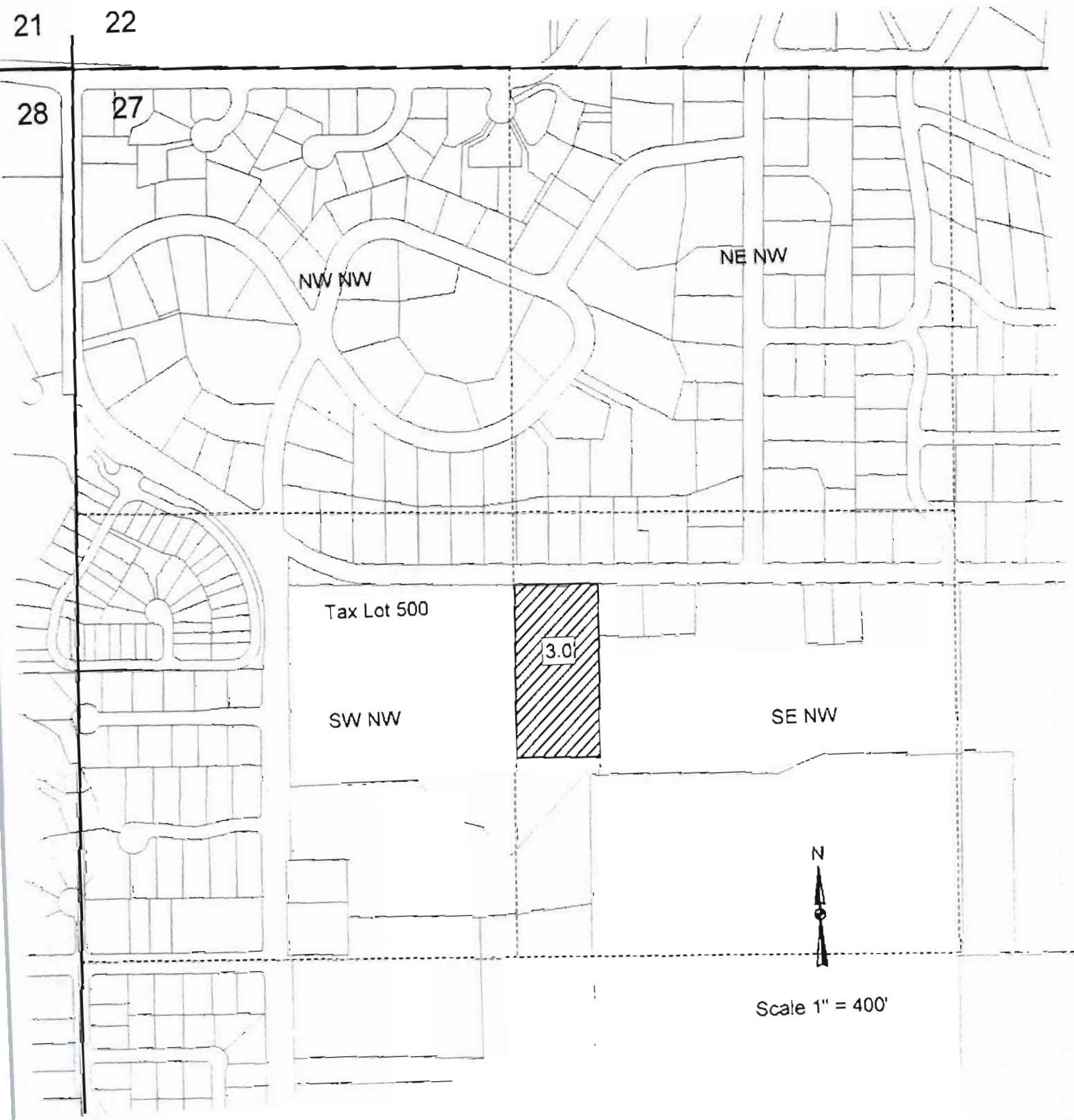

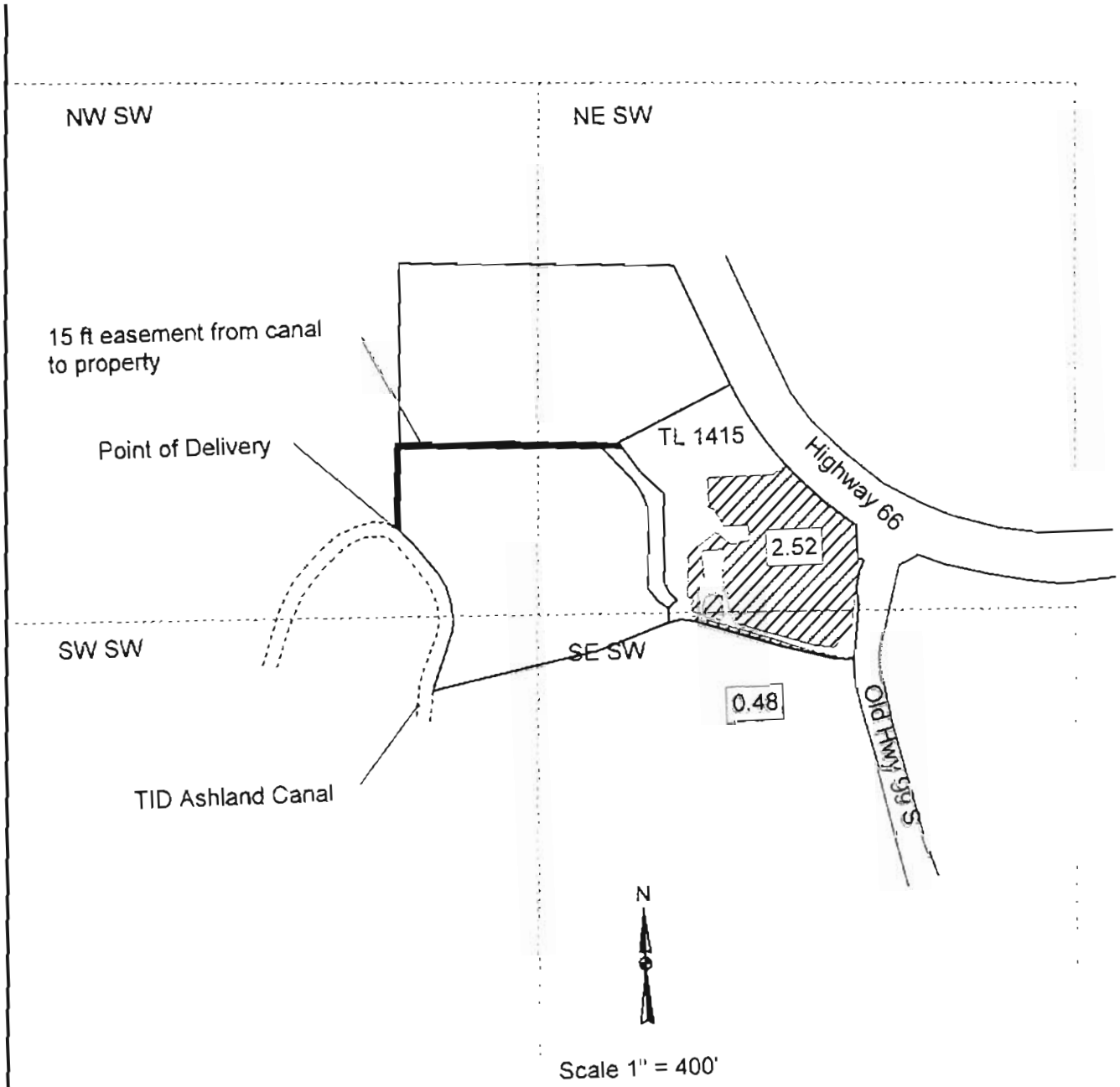
